Dear Mr. Duvall:

I received your May 24, 2001 voice mail message which stated that you had abandoned the Fones for Kids enterprise and that there has been no activity. Rule 25-24.514, Florida Administrative Code, provides that a certificated company must request cancellation of its certificate in writing and state its intent and date to pay the Regulatory Assessment Fees (RAF). Until the Commission receives a written request for cancellation, and our records do not reflect a request from you has been received, the certificate remains active. This also means that the RAF is due for a calendar year if the certificate is active for any day during a calendar year, in this case 2001.

Commission records show that the 2000 RAF has not been paid. Unfortunately, there is a minimum RAF due whether or not there has been any "activity". In addition to the 2000 and 2001 RAFs, penalty and interest charges are owed for calendar years 1999 and 2000. A breakdown of the charges is enclosed.

There are two kinds of cancellations. The first is voluntary, which is normally granted if the company is in good standing with the Commission and does not have a past due balance of the regulatory assessment fee (RAF), including statutory penalty and interest charges. The other is involuntary. If a company is **not** in good standing and has an outstanding balance of the RAF, the Commission normally cancels the certificate on its own motion for a rule violation. Any balance owed is forwarded to the Comptroller's Office for collection.

In order to resolve this docket and if you wish to cancel your certificate, you should write a letter to Ms. Blanca Bayó, Director, Division of Records and Reporting, Florida Public Service Commission, 2540 Shumard Oak Blvd., Tallahassee, FL 32399-0850 requesting cancellation. If you want a voluntary cancellation, payment of the past due amount in full should be included with your letter. If payment is not included, I will go forward with a recommendation to cancel your certificate on the Commission's own motion and recommend that any past due amount be forwarded to the Comptroller's Office for further collection efforts. The 2000 and 2001 RAF returns are enclosed.
