I am Julie Mathis, Executive Director of the Charlotte County Chamber of Commerce. The Chamber Board prefers the geographic split identified in your material at Alternative 4, at the Lee County line. In addition, we do not support an overlay system.

As you know, Charlotte County includes the community of Englewood, which is half in our County and half in Sarasota County. We believe that any geographic split should coincide with county boundaries. To mark a river or a road as a cut-off point would be a man-made barrier that could significantly alter our sense of community.

We also believe that an overlay, or 10-digit dialing, would be very confusing to our elderly population. According to 2000 census bureau statistics, Charlotte County is the nation's second oldest county, with a median age of 54.3 years. Charlotte County remains the state's oldest county, and we are ranked number two in the state with 3.6% of our population over 85 years of age. Sarasota County is number-one with 4% of its population over 85. I am not suggesting that our seniors are unable to dial ten numbers, but I do question why we would ask them to do so when it would be confusing and disruptive for so many.

In addition, Charlotte County is a small business community, with 59.5% having only 1-4 employees. It will cost anywhere from \$1,000 to \$10,000 for these businesses to reprint letterhead, business cards, invoices, and promotional brochures that would include an area code. And, while I understand that you don't want to ask any business community to incur these costs, I think it makes a stronger argument for this community, with its majority of small businesses, to keep its area code.

I am also here today as a member of the County's Tourist Development Council, that for the first time ever has expended more than a half million dollars to promote all of Charlotte County - from Punta Gorda to Englewood - as one tourist destination. These promotional efforts have put us on the map all over the world and have strengthened the ties between Charlotte and Sarasota counties.

For these reasons, we respectfully request that if the area code must be changes, that it be done at the Charlotte-Lee County line and that you do not implement the overlay program.

I'm sure your staff has looked at this, but perhaps cell phones should have separate area

code, or codes if needed, throughout the county. If the use of cell phones and faxes is the reason for these hearings every two years, wouldn't a separate area code for them help solve the problem?

Dear Chairman Jacobs:

Thank you for visiting the communities that will be affected by the 941 Area Code Relief Plan. I attended the meeting held in Port Charlotte and was pleased to see such a showing of community support and interest in such an important matter as the area code relief plan.

I am sure you will agree, the Charlotte County Citizens who spoke at the meeting unanimously agreed that the alternative #4 "geographic split-Punta Gorda North" is the most feasible and desired plan for our area. Many reasons were provided that gave validity to this argument for example; schools, hospitals, and other service facilities tie many of our communities together even though they are separated by distance. Case and point, although residents of Gasparilla Island are separated from Englewood by a bridge our communities are tied by the fact that our children attend Charlotte County Schools, and the nearest hospital is Englewood Community Hospital.

To complicate matters further Gasparilla Island is split into two counties. The northern 1/3 of the island is Charlotte County and the southern 2/3 is Lee County. As you well know, Fort Myers is the County seat and located 75 miles from Boca Grande. Although the larger portion of Gasparilla Island is located in Lee County it is the consensus of our membership that Boca Grande, if given a choice, would like to remain in the 941 are code district along with Charlotte County.

It was not that many years ago residents of Boca Grande enjoyed four-digit dialing of numbers on Gasparilla Island. Although we all realize those days are long gone, it does seem unreasonable to impose such a small geographically remote island with the complications that would arise from being assigned two different area codes.

The GICIA Board of Directors urge you to consider the implications of further dividing our communities and implement "alternative #4: Geographic Split –Punta Gorda North". If you have any questions regarding our support on this issue please do not hesitate to contact me.

On behalf of the Board of Directors and the 1100 business members of the Venice Area Chamber of Commerce, please accept this letter of support for Alternative 4, Geographic Split – Punta Gorda North, as outlined by the Florida Public Service Commission.

Recently I provided testimony at a public hearing held in Sarasota and made the following three points.

- 1) It is our opinion that this alternative is the most acceptable to meet both business and public concerns. A geographic split would eliminate the confusion caused by a distributed overlay alternative and keep Sarasota and Charlotte counties aligned with the same area code.
- 2) Based on #1, the new area code established should be assigned to the area with the lowest population, thereby impacting the least number of individuals and businesses.
- 3) A suitable alternative to those provided would be to assign a separate area code to cellular phones and paging systems within the 941 area code.

Dear Mr. Shreve:

Representative Jerry Paul has advised there will be a final public hearing on this issue before the PSC on June 18<sup>th</sup> in Tallahassee and arrangements have been made for additional written input to be inserted into the record for the hearing.

Proposed relief plan alternative #4 "geographic split – Punta Gorda North" is the most feasible and represents the one plan with the least detrimental economic impact on Charlotte County.

The Board of County Commissioners approved funding for an Economic Development Office in February of this year. To that end, we are building consensus within the County to unify the business community. Maintaining the 941 area code would assist in that regard.

Our County has geographic challenges within its boundaries, i.e. the unincorporated community of Englewood is in two counties and Englewood and Port Charlotte have two State House District boundaries. The services within the County are more aligned with Sarasota County to the north, thus the more logical alternative for the 941 area code is number four.

Please implement alternative #4 "geographic split - Punta Gorda North".
