NOTICE TO INTERESTED PERSONS OF SETTLEMENT  
OF DISPUTE INVOLVING SOUTHLAKE UTILITIES, INC.,  
IN FLORIDA PUBLIC SERVICE COMMISSION  
DOCKET NOS. 980992-WS AND 981609-WS  
Date: June 16, 2001

The Florida Public Service Commission ("Commission") recently voted to approve a settlement of a dispute between Southlake Utilities, Inc. ("Southlake"), and D. R. Horton Custom Homes, Inc. ("Horton"), in connection with Southlake's Allowance for Funds Prudently Invested ("AFPI") charges and service availability charges.

Horton had filed with the Commission several years ago a complaint regarding Southlake's procedures to collect the true-up amount for AFPI charges (i.e., the additional charges from the date of initial payment through the date of actual connection). Horton also had filed with the Commission fairly shortly thereafter a petition to challenge Southlake's service availability charges and AFPI charges. The Commission investigated Southlake's charges and determined that Southlake's use of the true-up procedures for its AFPI charges was appropriate. The remaining issues were then set for a hearing before the Commission.

Southlake over the past months has conducted an extensive and very costly investigation and then prepared an in-depth analysis of its service availability charges and AFPI charges in order to determine the correct level of charges and refunds and to reach a fair, just, and reasonable result. Horton also employed experts to conduct its own investigation of this matter. The Staff of the Commission conducted its own independent in-depth investigation and analysis of this matter in preparation for the hearing. Prior to the date for the hearing, Southlake and Horton reached what they believe to be an accurate resolution of this matter for Horton, all other developers in Southlake's service area, and Southlake, which will achieve a fair, just and reasonable result for all involved parties.

At its May 29, 2001, Agenda Conference, the Commission found that the provisions of the proposed settlement were reasonable and approved the settlement agreement reflecting such as being in the public interest. The settlement agreement will be effective when the last of the following occurs: (i) the date of the expiration of all appeals and protests of the Commission Order approving the settlement agreement; and (ii) the date of the expiration of all appeals and protests of the Commission Order approving the Application for

Transfer of Majority Organizational Control of Southlake which is currently pending before the Commission.

The settlement provides for a total refund by Southlake of AFPI charges, including true up charges and interest, collectively of \$403,614.79. The refund amounts by developer are set forth on Exhibit A of this Notice. The AFPI refunds to the listed developers are to be provided within ninety (90) days of the effective date of the settlement agreement in exchange for the execution and delivery by each receiving developer of a release, a copy of which is attached as Exhibit B. Southlake's collection of its currently approved AFPI charges has been discontinued and the related tariff sheets approving the AFPI charges will be cancelled.

There will be no refunds of service availability charges as such were found not to be inappropriately high, and in fact, such charges were determined to be too low. Southlake's water plant capacity charges will be increased from \$420.00 per Equivalent Residential Connection ("ERC") or \$1.20 per Gallon Per Day ("GPD") to \$433.00 per ERC or \$1.24 per GPD, respectively. Southlake's wastewater plant capacity charges similarly will be increased from \$775.00 per ERC or \$2.58 per GPD to \$970.00 per ERC or \$3.23 per GPD, respectively. The increase in plant capacity charges will be effective for connections made after the last to occur of: (i) the effective date of the settlement agreement; and (ii) the date of tariff sheets approving the change in plant capacity charges.
