

2) Emmanuel Arvanitas is a past consumer of BellSouth and is aware of it's inefficient ability to provide services. Having ported said number from BellSouth to Media One, said petitioner has become more involved by review of the 1996 Telecom Act, FCC orders 00-104 and 00-429, as well as Florida Statutes 120.80 and Florida Statutes 120.50 .

3) As a consumer and resident of Jacksonville, Florida, for over 20 years, according to Rule 25-22.039 I have a right to intervene as a consumer representative myself in proceedings which affect my area code. Since this is a review for expeditious rubber stamping of NANPA code denial of BellSouth's NXX's and they could occur and are occurring in the 904/386 area code region of which I live, my interests are severely affected as to the continual nature and exhaust of area code practices.

4) As an employee of Media One for over 17 years, I possess valuable information as to provisioning, equipment infrastructure questions that the Commissioners are lacking. And since the Telecom disn bureau chief Ms. Banks comes from electric and had no experience in telecom prior to her quid quo pro ordination to her post, I feel great fear in the insufficient knowledge of staff docket members deciding my area
