Jackie,

I based the dollar amount on the fine ordered in the Tescom Cancellation Order (PSC-99-2411-PAA-TC) of \$500 not \$1000, and the RAF's due via an email from a previous email we had dated 2/12/01 for amounts due with P&I as of 3/20/01 and a phone call to you to figure out an additional months worth of P&I, plus \$50 for 2001 as a good faith gesture towards future certification. Suggestion from Legal. They were suppose to mail it in April, but didn't. The 2001 Raf donation should more than cover the extra P&I due. There was suppose to be a letter addressed to me, but I haven't received any correspondence yet. I have been waiting for it.

Hi Jackie. I looked up the docket (No. 991298-TC) and found that this company's certificate was cancelled effective 01/05/00 for nonpayment of the RAF's and not providing the Commission with its updated reporting requirements. They were originally fined \$1,000. Therefore, if they are applying for a new certificate, I believe we would require them to pay the 1998, 1999, and 2000 RAFs, plus penalty and interest charges, the \$1,000 fine, and the \$100 application fee. So, the check you received for \$756 does not make sense to me.

However, Jackie Gilchrist's section handles applications, so I'm referring this to her to see if anyone in her section has had contact with this company. If not, the only thing I can suggest is that you call them and ask where it should be credited.
