Notification of the Reorganization and Transfer of Control in Ownership of Re: **Incomnet Communications Corporation**

Certificate 2684

Dear Ms. Bayo:

This letter is sent on behalf of Incomnet Communications Corporation ("ICC" or "Company") as notification to the Florida Public Service Commission that ICC, together with Incomnet, Inc. ("Incomnet"or "Parent"), a California corporation of which ICC is a wholly-owned subsidiary, entered into an agreement for the reorganization and transfer of control of ICC to Ironwood Telecom LLC ("Ironwood"), under terms of the Debtors' Third Amended Joint Chapter 11 Plan of Reorganization (the "Plan"). The Order confirming and implementing the Plan was issued by the U.S. Bankruptcy Court on May 9, 2000 for effect on May 22, 2000.

ICC is a Delaware corporation certificated as a reseller of interLATA telecommunications services by the Commission, Certificate No. 2684. Prior to reorganization, ICC, was a wholly-owned subsidiary of Incomnet, Inc. ("Incomnet"), a California corporation operating strictly as a holding company. Upon implementation of the Plan, Incomnet ceased doing business and its assets were liquidated. Ironwood Telecom LLC ("Ironwood"), a Colorado limited liability company, is a privately owned holding company which, under terms of the Plan, has only obtained stock ownership of ICC. Ironwood is not a certificated telecommunications provider in the state of Florida. No changes are required to the Certificate of ICC as the Company did not merge with Ironwood, but continues to function as the operating entity.

This transaction was transparent to the Customers of ICC as there was no interruption of service or major change in the management or operation of the Company. This transfer of ownership had no effect on Company name, address, contact information, services, rates or terms and conditions of service. The Company continues to market and bill in the name of Incomnet Communications Corporation.
