ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated May 14, 2001, OnePoint Communications-Georgia, LLC d/b/a OnePoint Communications, holder of Alternative Local Exchange Company (ALEC) Certificate of Public Convenience and Necessity No. 5250 and Interexchange Telecommunications (IXC) Certificate of Public Convenience and Necessity No. 5251, requested that Certificates Nos. 5250 and 5251 be amended to reflect the new corporate name, OnePoint Communications-Georgia, LLC d/b/a Verizon Avenue. Upon review of the Department of State, Division of Corporations' records, it appears that OnePoint Communications-Georgia, LLC d/b/a OnePoint Communications has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificates Nos. 5250 and 5251 to reflect the new corporate name.

This Order will serve as the amended ALEC Certificate of Public Convenience and Necessity No. 5250 and as the amended IXC Certificate No. 5251 for OnePoint Communications-Georgia, LLC d/b/a Verizon Avenue. OnePoint Communications-Georgia, LLC d/b/a Verizon Avenue should retain this Order as evidence of the name change. The Commission is vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.



Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
