Dear Ms. Sohlberg:

The Commission did not receive Mr. Nold's April 25 letter. We only received the 2000 RAF return and check. However, I cannot recommend that the Commission waive "any penalty" as Mr. Nold requested in the copy of the letter you attached to your e-mail. If the company wishes to keep its certificate active, Protel must submit a settlement proposal that includes all elements (Nos. 1 thru 5 on the attachment to my June 14 letter).

There is normally a \$1,000 fine associated with this rule violation when it is the second time a docket has been opened. In other similar cases, the Commission has accepted monetary settlement amounts between \$500 and the full \$1,000.
