Re: OnSite Access Local, LLC - Notification of Discontinuance of Service, Abandonment of Authority, and Revocation of Tariff

Dear Ms. Bayó:

On behalf of OnSite Access Local, LLC ("OnSite"), this letter is to notify the Florida Public Service Commission that OnSite intends to discontinue its provision of telecommunications service within the State of Florida as soon as possible due to the company's distressed financial condition. OnSite does not currently provide telecommunications service to any subscribers in Florida. OnSite further requests that its tariffs and certificates of authority to provide telecommunications service in Florida be cancelled.

By way of background, OnSite is a New York limited liability company headquartered in New York City. OnSite is authorized to provide resold and/or facilities-based interexchange and local exchange telecommunications service in various states. In Florida, OnSite is authorized to provide local exchange and interexchange telecommunications services pursuant to Commission orders issued in Docket Nos. 000195-TX and 000194-TI.

Due to adverse developments in the telecommunications industry, OnSite has filed for bankruptcy protection and will discontinue the provision of telecommunications service in the State of Florida as soon as possible. In the states that it does have customers, OnSite will notify its subscribers of its intention to cease operations, and will assist its customers to transition their service to other carriers. To ensure the smooth transfer of each customer, OnSite has developed a customer notification and transfer plan that is intended to provide the greatest opportunity for customer awareness, the informed exercise of customer choice, and a seamless transition with no service interruption to the customers' selected carriers. OnSite customers will receive adequate written notices regarding the discontinuance of OnSite service and the need to elect a new service provider. OnSite intends to discontinue service as soon as practical, but in no event will it be able to maintain service in any of its territories beyond August 15, 2001. As mentioned






