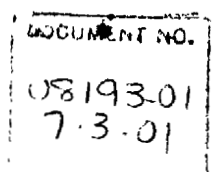
NOTICE OF PROPOSED AGENCY ACTION  
ORDER APPROVING TRANSFER OF CONTROL

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service  
Commission that the action discussed herein is preliminary in  
nature and will become final unless a person whose interests are  
substantially affected files a petition for a formal proceeding,  
pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may  
not acquire ownership or control of any telecommunications  
facility, or any extension thereof for the purpose of providing  
telecommunications services to the public, including the  
acquisition, transfer, or assignment of majority organizational  
control or controlling stock ownership, without prior approval from  
this Commission.

By letter dated April 16, 2001, IDT Corporation (IDT Corp.),  
IDT Telecom, Inc. (IDT Telecom) and IDT America Corp. (IDT America)  
(collectively "companies") filed with this Commission an

application for approval of intracorporate transfer of control of IDT America Corp. from IDT Corp. to IDT Telecom. IDT America is the holder of Interexchange Telecommunications Certificate Certificate No. 3581. The companies have stated that the transaction will be virtually transparent to their customers in Florida and it will not affect the services being provided. The companies have stated that IDT America will continue to operate under its existing certificated names and tariffs on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of IDT Corp., IDT Telecom and IDT America, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that IDT Corporation, IDT Telecom, Inc. and IDT America Corp.'s request for approval of transfer of control of IDT America Corp. from IDT Corporation to IDT Telecom, Inc. is hereby approved. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings or Judicial Review" attached hereto. It is further

ORDERED that in the event this Order becomes final, this Docket shall be closed.
