

MOTION FOR LEAVE TO FILE AMENDED PETITION

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 28-106.202, Florida Administrative Code, respectfully requests that it be granted leave to file an Amended Petition. An Amended Petition is necessary to set forth that BellSouth is no longer requesting that the Commission reverse the decision of the Pooling Administrator, NeuStar, to deny BellSouth's request for additional numbering resources for the Ft. Lauderdale-Sawgrass switch. Since the filing of the Petition, the customer identified in the Petition in the Ft. Lauderdale-Sawgrass switch that needed additional numbering resources has decided to obtain service from an ALEC solely because BellSouth was unable to fulfill its numbering demands. Accordingly, the Amended Petition removes any reference to the Ft. Lauderdale-Sawgrass switch. BellSouth attempted to contact NeuStar to determine if it objected to the filing of an Amended Petition. At that time of filing, BellSouth has not been able to obtain NeuStar's response.


WHEREFORE, BellSouth respectfully requests that the Commission grant it leave to file the attached Amended Petition.
