- 3. Walt Disney World is a retail customer of Florida Power Corporation ("FPC").
- 4. The Commission has initiated this rate proceeding, among other things, "to address the level of FPC's earnings and to assure appropriate retail rates are implemented on a going forward basis so that appropriate benefits of the formation of [GridFlorida, the regional transmission organization proposed for peninsular Florida,] and any future restructuring of the electric market are captured for the retail ratepayer." In re: Review of Florida Power Corporation by Carolina Power & Light, Docket No. 000824-EI, Slip. Op. at 2 (June 20, 2001).
- 5. Because Walt Disney World is a retail consumer of electricity provided by FPC, and because this proceeding is designed to consider the impact that the formation of GridFlorida and any future restructuring efforts by FPC will have for its retail customers, Walt Disney World will be substantially affected by any action the Commission takes in this docket.
