RESOLUTION NO.:00/01-128

A RESOLUTION OF THE OSCEOLA COUNTY BOARD OF COUNTY COMMISSIONERS PROVIDING FOR AN ANALYSIS OF NEEDS FOR THE FOUR CORNERS AREA; PROVIDING FOR EQUAL FUNDING OF A NEEDS ANALYSIS BY AND THROUGH THE COUNTIES OF LAKE, ORANGE, OSCEOLA AND POLK; PROVIDING FOR NOTICE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Counties of Lake, Orange, Osceola and Polk find it necessary to work in conjunction with one another to provide for the citizens of what is commonly referred to as the Four Corners area.

WHEREAS, the health, safety and welfare of the citizens of the Four Corners area will be best served by coordinating the efforts of Lake, Orange, Osceola and Polk Counties.

NOW THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Osceola County, Florida:

SECTION 1. GENERAL PROVISIONS.

- Osceola County desires to work in conjunction with the Counties of Lake, Orange, and Polk by funding twenty-five percent (25%) of a "Needs Analysis" which is to be conducted so as to determine the best way to provide for the citizens of the Four Corners area.
- 2. The "Needs Analysis" shall not exceed Fifty Thousand Dollars (\$50,000.00), the cost of which shall be shared equally among the four Counties.
- 3. The "Needs Analysis" shall be completed by the 31st day of December, 2001.
- 4. Osceola County shall designate a "contact person" to assist the Regional Planning Councils during the information gathering and research of the "Needs Analysis".

SECTION 2. NOTICE.

The Clerk of the Board shall, as soon as possible, notify the Florida Public Service Commission of the adoption of this Resolution and shall mail a certified copy of same to the Office of Records and Reporting for the Florida Public Service Commission in Tallahassee, Florida.

SECTION 3. SEVERABILITY.

If any section of this Resolution, or the application thereof, is held invalid, the invalidity shall not affect other provisions or applications of this Resolution, which can be given affect without the invalid provision or application, and to that end, the provisions of this Resolution are declared severable.

SECTION 4. CONFLICT.

Any Resolution, or part thereof, which is in conflict with this Resolution is hereby repealed to the extent of such conflict.

SECTION 5. EFFECTIVE DATE.

This Resolution shall be in force and take effect immediately upon its passage and adoption.
