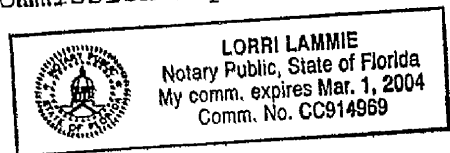

NOTICE OF APPLICATION FOR AN EXTENSION

Highlands Utilities Corporation, 720 US 27 South, Lake Placid, FL 33852-9515, pursuant to Section 367.045, Florida Statutes, hereby notices its intent to apply to the Florida Public Service Commission for an extension of its service area to provide wastewater service to Highlands County, Florida, more particularly described as follows:

**Section 6, Township 37 South, Range 30 East
(Roberts Grove Parcel)**

The East 1 /2 of the Northeast 1/4 of the Northwest 1/4 of Section 6, Township 37 South, Range 30 East.

**Section 31, Township 36 South, Range 30 East
(Watersedge, Yesteryears, The Pines of Lake Huntley Condo)**

The South 2,050 feet of the East 1 /2 of the East 1/ 2 all lying South of County Road 621 of Section 31, Township 36 South, Range 30 East.

**Section 32, Township 36 South, Range 30 East
(Yesteryears Parcel)**

The South 1,150 feet of the West 300 feet of the Southwest 1/4 of Section 31, Township 36 South, Range 30 East, all North of Lake Huntley.
