Dear Sir/Madam:

BroadBand Office Communications, Inc. ("BBOC"), by its undersigned counsel, hereby notifies the Florida Public Service Commission ("Commission") of BBOC's intention to cease providing Alternative Local Exchange Telecommunications service within the State of Florida. BBOC respectfully requests the Commission to cancel its certificate.<sup>1</sup>

On May 9, 2001, the parent company of BBOC, BroadBand Office, Inc. ("BBO"), filed for protection under Chapter 11 of the Bankruptcy Code in the U.S. District Court in the District of Delaware. Despite numerous efforts to secure additional financing to keep its retail business operational, BBO was unable to find a buyer for the business. As such, BBOC has no choice but to terminate service to customers in Florida.

To that end, on May 10, 2001, BBO sent a notice to all customers in Florida indicating that it was in bankruptcy and that it and its subsidiaries intend to discontinue service to all customers.

BBOC provides service to three voice customers in the State of Florida.

On February 8, 2000, the Commission granted BBOC a Certificate to Provide Alternative Local Exchange Telecommunications Services throughout the State of Florida.
