

Dieca Communications, Inc. d/b/a Covad Communications Company (Covad), pursuant to Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Specified Confidential Classification.

1. On July 19, 2001, Covad filed its Post-Hearing Brief in this matter. The brief contains contains BellSouth confidential information at pages 28 and 29. BellSouth considers the information described above to be confidential and/or proprietary and it is governed by a Protective Agreement between the parties. BellSouth previously filed a Notice of Intent to Request Specified Confidential Classification and a Request for Confidential Classification for this information.
