**FLORIDA INDUSTRIAL POWER USERS GROUP'S RESPONSE
TO TAMPA ELECTRIC COMPANY'S MOTION FOR PROTECTIVE ORDER**

The Florida Industrial Power Users Group (FIPUG) files its Response to Tampa Electric Company's (TECo) Motion for Protective Order filed July 20, 2001. Such motion should be denied.


1. On June 19, 2001, FIPUG served its Second Set of Interrogatories and Second Request for Production on Documents on TECo.

2. On July 20, 2001, TECo filed a Motion for Protective Order, seeking to have FIPUG sign a nondisclosure agreement prior to answering Interrogatory Nos. 24(c) and 28. The agreement TECo proposes would not only require that the information be kept confidential but that no FIPUG member have access to it.

3. The reasons TECo advances are substantially the same as those set out in its July 12 Motion for Protective Order.

4. FIPUG responded to TECo's July 12 motion on July 19 and incorporates and adopts its response herein.

WHEREFORE, TECo's Motion for Protective Order should be denied and its should be required to respond immediately to FIPUG's discovery.


