Dear Mr. Lobozzo:

I received a facsimile dated July 18, 2001 (attached), from your client, Ms. Sara S. Keller, inquiring about the above captioned docket. While the Commission is always willing to address customer concerns, because this case is scheduled for a hearing, all communication between the parties represented by counsel should be between the respective counsel.

In the facsimile, Ms. Keller wanted to know whether Highlands Utilities Corporation (Highlands) has agreed to the correction of territory. Staff has received an agreement between The Woodlands of Lake Placid, L.P. (Woodlands) and Highlands to delete the territory certificated to Highlands, but is currently being served by Woodlands.

Ms. Keller also wanted to know whether she had to file another objection pursuant to the current notice. The current notice is to correct the earlier notice pursuant to which Ms. Keller, et al., filed an objection. Therefore, she does not need to object to the current notice, nor does she need to renew her current objection.

Ms. Keller also raised concerns about the billing date of her monthly billings. Staff has contacted Woodlands and it confirmed that the billing software had sent incorrect bills during the month of May. However, Woodlands has assured staff that this problem has been corrected. If Ms. Keller is still receiving incorrect bills, she may send the bills to Stephanie Clapp in the Division of Regulatory Oversight, so that we can further investigate the matter.

Finally, Ms. Keller wanted to know if any further action was required at this time as a result of the most recent application. Please inform Ms. Keller that no further action is required at this time.
