


**TALK AMERICA, INC.'S AMENDED

Comes now Talk America, Inc., f/k/a Talk.com Holding Corp. d/b/a Network Services d/b/a The Phone Company and The Other Phone Company d/b/a Access One Communications ("Talk America" collectively) pursuant to section 364.183, Florida Statutes, and Rule 25-22.006(6) and amends its request for a temporary protective order filed July 23, 2001, and states:

1. On July 23, 2001, July 25, 2001 and July 27, 2001, Talk America submitted objections and responses to the Citizens First Set of Request for Production of Documents at the same time, Talk America filed a Request for Temporary Protective Order as to the documents provided to Citizens.

2. Talk America has submitted additional documents responsive to Item 1 of the Production of Documents on July 30, 2001. These documents, like the ones produced on July 23, 2001, July 25, 2001 and July 27, 2001, contain information regarding customers and the Company which is and should be treated as proprietary and confidential. 
