

Please be advised that the owner of Mercury Marketing Company, Ltd., Steven Loewenstein, died a year ago. While his wife made every effort to continue operating the company, she has been unsuccessful. The decision was made to close Mercury Marketing Company, Ltd. at the end of 2000. Many of the past due liabilities of the company were paid in 2000 but some are remaining. I have referred Mrs. Loewenstein to a bankruptcy attorney in New Jersey, but I do not believe a bankruptcy will be filed. There are no assets remaining in the company from which to pay the remaining liabilities. However, the decision to file is not mine and will be made in the next few weeks.
