



MOTION FOR RECONSIDERATION

BellSouth Telecommunications, Inc. ("BellSouth") respectfully requests that the Florida Public Service Commission ("Commission") reconsider and modify Order No. PSC-01-1522-PCO-TL ("Order") issued on July 23, 2001 for the following reasons.

1. In the Order, the Prehearing Officer set the hearing for this matter on December 20, 2001 and stated that no further continuances would be granted. Said hearing has been continued twice, once *sua sponte* by the Commission and once pursuant to the request of Mr. Anthony Parks.

2. BellSouth requests that the Commission reconsider and modify its Order and set the hearing for another date because one of BellSouth's witnesses will not be available on December 20, 2001 due to a personal commitment.


3. BellSouth apologizes in informing counsel for Commission Staff that BellSouth would be available on December 20, 2001 when said counsel called the undersigned approximately two months ago. The undersigned agreed to the available dates – believed to be August 30, December 20, and December 21 – prior to confirming that BellSouth's witnesses would be available for those specific dates.

4. BellSouth has contacted Mr. Parks and understands that Mr. Parks has no objection to the selection of another hearing date. Further, BellSouth understands and is willing to accept, as the Petitioner, the fact that it is unlikely that another hearing date can be obtained in 2001.


