NOTICE OF PROPOSED AGENCY ACTION  
ORDER CANCELLING INTEREXCHANGE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service  
Commission that the action discussed herein is preliminary in  
nature and will become final unless a person whose interests are  
substantially affected files a petition for a formal proceeding,  
pursuant to Rule 25-22.029, Florida Administrative Code.

The entities listed below have complied with the provision of  
Rule 25-24.474(2), Florida Administrative Code, by providing  
adequate notice in writing of their request for cancellation of  
their Interexchange Telecommunications (IXC) certificates and by  
submitting their Regulatory Assessment Fees (RAFs) for 1999.  
Accordingly, we find it appropriate to cancel the certificates

Dear Ms. Gaines:

The Commission received your RAF return for the period January 1 through July 7, 2000, however, there was no check for the minimum amount enclosed. A copy of your 2000 return is enclosed.

The RAF is assessed if a certificate is active for any one day during a calendar year and is due by January 30 of each year, unless the 30th falls on a weekend, then the fee is due by the next working day, for the previous year. The RAF is .0015% of a company's total revenues or \$50, whichever is greater. If payment for the RAF is mailed after the due date, then statutory penalty and interest charges are applicable. If payment is postmarked by June 29, 2001, the 2000 total is \$65.00 (\$50.00 fee, \$12.50 penalty, and \$2.50 interest). If payment is postmarked between June 30 and July 29, 2001, the interest charge increases to \$3.00, or a total minimum amount of \$65.50.

Your company's certificate was voluntarily cancelled in Docket No. 000852-TI. Order No. PSC-00-1432-PAA-TI was issued on August 4, 2000, and stated in pertinent part:

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee of \$50 if the certificate was active during any portion of the calendar year. A RAFs return notice for 2000 will be mailed to each of the above entities. Neither the cancellation of their certificates nor the failure to receive a RAFs return notice for 2000 shall relieve these entities from their obligation to pay RAFs for 2000.

It should be noted that any unpaid RAF, including statutory penalty and interest charges, will be turned over to the Florida Comptroller's Office for further collection efforts.
