Dear Mr. MacKenzie:

I've received your recent letter proposing a \$100 settlement to resolve Docket No. 010530-TC. Unfortunately, it does not have all of the elements in order for staff to recommend accepting the settlement. Attached is a sample settlement that was approved by the Commission for a pay telephone company in a similar situation. Basically, settlement proposals should include the following elements:

- 1) Docket number;
- 2) A statement that the company has taken steps to prevent future late payments of the Regulatory Assessment Fee and what those steps are;
- 3) A waiver of objection, which should state: The company agrees to waive any objection to the administrative cancellation of its certificate should it fail to pay in accordance with its settlement offer. If, however, there is a factual dispute as to the manner or level of compliance with any provision in the settlement, Commission staff will bring the matter to the Commission for consideration; and
- 4) Make a specific monetary settlement.

Your proposal only included the first and last elements. In addition, the settlement should be addressed to Ms. Blanca Bayó, Director, Division of the Commission Clerk & Administrative Services, Florida Public Service Commission, 2540 Shumard Oak Blvd., Tallahassee, FL 32399-0850. The proposed settlement amount should not be paid at this time, instead only the past due
