Re: Approval of a Name Change Amendment to the Interconnection, Unbundling, Resale and Collocation Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and AMAFLA Telecom, Inc. pursuant to Sections 251, 252 and 271 of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and VCV Communications, Inc. d/b/a AMAFLA Telecom, Inc. are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to VCV Communications, Inc. d/b/a AMAFLA Telecom, Inc.. The initial agreement between the companies was submitted to the Florida Public Service Commission for approval on May 12, 2001 in Docket 010834-TP. This amendment changes the name of AMAFLA Telecom, Inc. throughout the agreement to VCV Communications, Inc. d/b/a AMAFLA Telecom, Inc.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the negotiated agreement between BellSouth and VCV Communications, Inc. d/b/a AMAFLA Telecom, Inc. within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties aver that neither of these reasons exist as to the agreement they have negotiated and therefore, are very hopeful that the Commission shall approve their agreement.

**AMENDMENT
TO THE
INTERCONNECTION AGREEMENT BETWEEN
AMAFLA TELECOM, INC. AND
BELLSOUTH TELECOMMUNICATIONS, INC.
DATED MAY 16, 2001**

Pursuant to this Amendment to the Interconnection Agreement between AMAFLA Telecom, Inc. and BellSouth Telecommunications, Inc. (the "Amendment"), AMAFLA Telecom, Inc. ("AMAFLA") and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated May 16, 2001 ("Interconnection Agreement").

WHEREAS, AMAFLA has changed its name to VCV Communications, Inc. d/b/a AMAFLA Telecom, Inc., a Florida corporation; and

WHEREAS, the Parties desire that the Interconnection Agreement be amended to reflect the correct corporate entity name for AMAFLA;

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The name of AMAFLA in the Interconnection Agreement is hereby deleted throughout the Interconnection Agreement and replaced with VCV Communications, Inc. d/b/a AMAFLA Telecom, Inc. ("VCV").
2. All of the other provisions of the Interconnection Agreement, dated May 16, 2001 shall remain in full force and effect.
3. Either or both of the Parties is authorized to submit this Amendment to each Public Service Commission for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
