On June 18, 2001, the Commission received your letter dated June 14 requesting cancellation of the company's Interexchange Carrier (IXC) and Alternative Local Exchange Carrier (ALEC) • certificates. There are two kinds of cancellations. The first is voluntary, which is normally granted if the company is in good standing with the Commission and does not have a past due balance of the Regulatory Assessment Fee (RAF), including statutory penalty and interest charges. The other is involuntary. If a company is <u>not</u> in good standing and has an outstanding balance of the RAF, the Commission normally cancels the certificate on its own motion for a rule violation. Any balance owed is forwarded to the Comptroller's Office for collection.

The RAF is assessed if a certificate is active for any one day during a calendar year and is due by January 30 of each year, unless the 30th falls on a weekend, then the fee is due by the next working day, for the previous year. If payment for the RAF is mailed after the due date, then statutory penalty and interest charges are applicable. The RAF is due for each certificate.

According to Commission records, the company paid the RAF and a portion of the penalty on its IXC certificate, but as of this date, the 2000 RAF has not been paid on its ALEC certificate. A breakdown of the charges is attached. Depending upon when the payment is postmarked, penalty and interest charges will continue to accrue on the ALEC certificate.

The effective date of a voluntary cancellation is the date that the Commission received a company's request for cancellation. In this case, the Commission did not receive your request until June 18, 2001, therefore, the company will owe the 2001 RAF, even if the company is no longer in business. Rules 25-24.474 and 25-24.820, Florida Administrative Code, provide that a company requesting voluntary cancellation must either pay the 2001 RAF or provide a date certain that it will be paid, such as within 30 days after the Commission Order is issued granting the voluntary cancellation. It should be noted that any unpaid RAF, including penalty and interest charges, will be turned over to the Comptroller's Office for further collection efforts. The 2000 and 2001 RAF return forms for the ALEC and the 2001 RAF return form for the IXC are enclosed.
