NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING CERTIFICATE TO PROVIDE INTEREXCHANGE TELECOMMUNICATIONS SERVICES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On December 29, 1999, we granted New Edge Network, Inc. d/b/a New Edge Networks (New Edge) Certificate of Authority No. 7280 to provide interexchange telecommunications service in Florida. On January 8, 2001, in Docket No. 001385-TI, the Commission issued Order No. PSC-01-0044-PAA-TI for apparent violation of Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies. New Edge was ordered to pay the past due RAF, statutory penalties, interest charges and a \$500 fine. Failure to comply with the Order would result in cancellation of the certificate. On February 12, 2001, Certificate of Authority No. 7280 was canceled. On May 8, 2001, New Edge paid the 1999 RAF with penalty and interest. On May 18, 2001, New Edge filed a new application to

provide Interexchange Telecommunications (IXC) services in Florida. The company paid the \$500 fine and the 2001 RAF for certificate No. 7280 on July 18, 2001.

New Edge has applied for a certificate to provide IXC services pursuant to Section 364.337, Florida Statutes. Upon review of its application, it appears that New Edge has sufficient technical, financial, and managerial capability to provide such services. Accordingly, we hereby grant Certificate No. 7905 to New Edge.

If this Order becomes final and effective, it shall serve as New Edge's certificate. New Edge should, therefore, retain this Order as proof of certification. The Commission is vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.337, Florida Statutes.

IXC providers are subject to Chapter 25-24, Florida Administrative Code, Part X, Rules Governing Telephone Service Provided by Interexchange Telephone Companies. IXC providers are also required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapter 25-4, Florida Administrative Code.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee (RAFs) of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed each December to New Edge for payment in January. Neither the cancellation of the certificate nor the failure to receive a RAFs Return notice shall relieve New Edge from its obligation to pay RAFs.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that we hereby grant Certificate No. 7905 to New Edge Network, Inc. d/b/a New Edge Networks, which shall authorize it to provide Interexchange Telecommunications services, subject to the terms and conditions specified in the body of this Order. It is further

ORDERED that this Order shall serve as New Edge Network, Inc. d/b/a New Edge Networks's certificate and should be retained by New

Edge Network, Inc. d/b/a New Edge Networks as proof of certification. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed.

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
