IXC Certificate No. 5243 and Withdrawal of Tariff 011084-TI

Dear Ms. Bayo:

On behalf of CapRock Telecommunications Corp. ("CapRock"), this letter notifies the Commission that CapRock hereby surrenders its Interexchange Telecommunications Service Certificate No. 5243, granted by Commission Order No. PSC-97-1247-FOF-TI ("IXC Certificate").<sup>1</sup> In addition, CapRock hereby withdraws and cancels its tariff currently on file with the Commission.

CapRock does not currently serve any customers in the State of Florida and, due to changes in its business plans, desires to cease offering intrastate telecommunications services in Florida. Because CapRock does not currently serve any customers in Florida, CapRock respectfully submits that the surrender of its Certificate and withdrawal of its tariff is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.

It is CapRock's understanding that the Commission may require the return of IXC Certificate No. 5243. CapRock regrets to notify the Commission that it is unable to return its Certificate because, despite its best efforts, it has been unable to locate IXC Certificate No. 4253 among its records.


