**NOTICE OF BAR DATE FOR FILING ADMINISTRATIVE CLAIMS**

On July 19, 2001, Picus, Inc., Picus Communications, LLC, Sybercom, Inc., iPlus Internet Services, Inc. and Internet Enterprise Center, Inc. (collectively the "Debtors" or "Picus"), filed a Motion to Set Bar Date for Filing Administrative Claims and Memorandum in Support (the "Motion"), in their jointly administered chapter 11 cases. A hearing on the Motion was conducted on August 23, 2001. No party appeared in opposition to the relief requested in the Motion. At the hearing, the Court approved the establishment of a bar date and an order has been tendered to the Court for entry.

**TAKE NOTICE THAT** all applications seeking allowance of claims against the Debtors, incurred on or after November 7, 2000 and before August 1, 2001, which claims are alleged to be entitled to priority pursuant to 11 U.S.C. § 507(a)(1), other than those for professional services under 11 U.S.C. § 503(b)(2) or (4) ("Administrative Claim"), shall be filed with this Court on or before **Friday, September 21, 2001**. Unless an application seeking allowance of an Administrative Claim has been filed on or before September 21, 2001, such administrative claim shall be disallowed.

Any application must be filed with and received by the Clerk of the Bankruptcy Court, U.S. Bankruptcy Court, P.O. Box 1938, Norfolk, VA 23501-1938, with a copy to counsel for the Debtor at the address set forth below, **on or before Friday, September 21, 2001**. Please govern your actions accordingly.
