Ms. Bayó,

Compact Data Systems, Inc. (CDSI) moved its main offices early this year and subsequently failed to pay its regulatory assessment fees (RAF) because the paperwork was either misplaced or ignored. Subsequent postal service problems hampered the issue and further notice from the Commission was lost. However, CDSI would like to keep its certificate active and has proposed the following settlement:

CDSI has taken steps to ensure future regulatory assessment fees will not be made late. These steps include installing new bookkeeping software, a change in accounting management, and new company policies involving correspondence from the Public Service Commission.

The company agrees to waive any objection to the administrative cancellation of its certificate should it fail to pay in accordance with the settlement offer.

CDSI would like to offer the Commission a \$100 settlement in order to keep the certificate active. We are a very small company and a larger settlement could possibly be detrimental to our day-to-day operations. Thank you for considering this offer.
