This letter is responding to Paula J. Isler's letter of August 10, 2001 regarding a docket opened by the Florida Public Service Commission for nonpayment of the 2000 Regulatory Assessment Fee.

- 1) Docket No. 010892-T1
- 2) Enclosed is our completed Return and a check for \$66.00, representing the minimum \$50.00, plus penalty and interest. We currently have no Florida Intrastate Revenue, but wish to keep our certificate active, as we hope to develop intrastate business in the future.
- 3) The Company has established a master calendar to track regulatory filing deadlines, and January 30<sup>th</sup> is clearly identified as the due date for the Interexchange Company Regulatory Assessment Fee Return. We will ensure that future filings are timely.
- 4) The Company agrees to waive any objection to the administrative cancellation of its certificate should it fail to pay in accordance with its settlement offer.
- 5) The Company recognizes its culpability in not submitting the filing by the required due date, and acknowledges the Commission's authority and right to impose a fine. We believe, however, that a \$500.00 fine, which might be proportionally appropriate for a large carrier, would be excessive for a small company falling under the minimum filing fee of \$50.00. Therefore, we propose a settlement of \$10.00, which represents 20% of that fee.

Thank you for your assistance and consideration. Please advise us of your decision.
