**IDS TELCOM, LLC'S MOTION TO MODIFY
THE ORDER OF IDS' WITNESSES**

IDS Telecom, LLC ("IDS"), by and through its undersigned counsel, respectfully requests to modify the order of its witnesses for the hearing scheduled in the above-referenced matter for September 21, 2001, and October 1, 2001, and as grounds therefore, states as follows:

1. The Commission held a Prehearing Conference in this matter on September 10, 2001. IDS submitted its order of witnesses to the Staff Attorney on September 12, 2001. IDS indicated that it desired to put on its direct witnesses prior to BellSouth Telecommunications, Inc.'s ("BellSouth's") direct and rebuttal witnesses, and its rebuttal witnesses after BellSouth's witnesses, during the final portion of the hearing.


