

(filed in two separate agreements) pursuant to Order No. PSC-01-1784-FOF-TP, dated August 31, 2001. These agreements were due to be filed on September 14, 2001, however due to the national disaster that has impaired the overnight mail service, BellSouth was only able to file the executed signature pages.
