PLEASE TAKE NOTICE that on December 6, 2000, the Honorable Peter J. Walsh entered an order (the "Order") in the cases of the above-captioned debtors and debtors in possession (the "Debtors") setting a bar date of January 15, 2001 for filing proofs of claim.

1. For purposes of this Notice, "Claim" shall mean (a) right to payment, whether or not such right is reduced to judgment, liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal,

equitable, secured or unsecured; or (b) right to an equitable remedy for breach of performance if such breach gives rise to a right to payment, whether or not such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured or unsecured.

2. The following creditors **NEED NOT FILE A PROOF OF CLAIM**: any person or entity, including, without limitation, individuals, partnerships, corporations, estates, trusts and governmental units (collectively "Party" or "Parties") whose Claim is listed as "fixed," "liquidated" or "undisputed" in the Debtor's schedules of assets and liabilities (the "Schedules") and who agrees with the amount and classification of the Claim as set forth therein. If you wish to determine whether you need to file a Claim, you should check the Schedules. 3. All Parties who have a Claim against the Debtors that arose:
- a. prior to August 16, 2000, except those parties described in Paragraph 2 or
  - b. pursuant to the rejection of an executory contract or lease within thirty (30) days following the entry of an Order authorizing assumption or rejection of such contracts or leases.

**MUST, ON OR BEFORE JANUARY 15, 2001 (THE "BAR DATE") FILE PROOFS OF CLAIM AGAINST THE DEBTORS.**

If you want a time-stamped copy, please include a copy along with a stamped, self-address return envelope and the Claims Agent will return a copy of your proof of claim to you. Do not file or send copies of claims to the chambers of Judge Peter J. Walsh, the Debtor, or the Debtor's counsel.

5. **ANY PARTY WHO FAILS TO FILE A PROOF OF CLAIM ON OR BEFORE THE BAR DATE, ABSENT FURTHER ORDER OF THE COURT, SHALL BE BARRED, ESTOPPED AND PRECLUDED FROM EVER (A) ASSERTING CLAIMS THAT SUCH PARTY POSSESSED AGAINST THE DEBTOR; AND (B) VOTING UPON, OR RECEIVING DISTRIBUTIONS UNDER, ANY PLAN OF REORGANIZATION.**

6. **ANY PARTY WHOSE CLAIM ARISES FROM, OR AS A CONSEQUENCE OF, REJECTION OF AN EXECUTORY CONTRACT OR AN UNEXPIRED LEASE AFTER JANUARY 15,**

2001, BUT PRIOR TO THE ENTRY OF AN ORDER BY THE BANKRUPTCY COURT CONFIRMING DEBTORS' PLAN OF REORGANIZATION, MUST FILE ITS PROOF OF CLAIM ON OR BEFORE THE LATER OF (A) 30 DAYS AFTER THE DATE OF THE ORDER OR NOTICE REJECTING SAID CONTRACT OR LEASE OR (B) THE BAR DATE.

7. The Debtors reserve the right to dispute, or to assert offsets or defenses to any Claim reflected on the Schedules as to amount, liability, classification or otherwise and to designate subsequently any Claim as disputed, contingent, unliquidated or undetermined; provided, however, that if any of the Debtors amend their Schedules to designate a Claim as disputed, contingent, unliquidated or undetermined, or to change the amount of a Claim reflected thereon, then, and in such event, upon further order of this Court, the affected Creditor shall be granted a reasonable time to file a proof of claim. Nothing set forth herein shall be deemed to preclude the Debtors from objecting to any Claim, whether scheduled or filed, on any grounds.
