BellSouth Telecommunications, Inc. ("BellSouth") and IDS Long Distance, Inc., n/k/a IDS Telecom, L.L.C. ("IDS"), hereby file, pursuant to Rule 25-22.006, Florida Administrative Code, its Joint Request For Confidential Classification, and states the following:

1. On September 17, 2001, BellSouth filed its Surrebuttal Testimony of John Ruscilli, Janet Miller Fields, Jimmy Patrick, Pat Rand and Linda Tate. Exhibit JAR-1 to John Ruscilli's Surrebuttal Testimony contains information that is considered confidential and proprietary to IDS.

2. Pursuant to Rule 25-22.06(3)(a), BellSouth and IDS are now filing a Joint Request for Confidential Classification for the subject information because the information contained in Exhibit JAR-1 to John Ruscilli's Surrebuttal Testimony contains customer-specific information that is considered confidential and proprietary to IDS. A more specific description of this information is contained in Attachment A.

3. IDS has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.


