





Per the document LSF is valid only on REQTYPE E (Resale), it is required in Florida per a PSC mandate effective June 1, 1999. It is available in AL, GA, KY, LA, MS, NC and SC effective 3/20/2000. It is not required or available in Tennessee per the CDIA document.
