PETITION OF FLORIDA POWER & LIGHT COMPANY FOR APPROVAL OF ITS GPIF TARGETS AND ESTIMATED BENCHMARK LEVEL FOR GAINS ON NON-SEPARATED WHOLESALE ENERGY SALES ELIGIBLE FOR A SHAREHOLDER INCENTIVE

Florida Power & Light Company ("FPL"), pursuant to Order No. 9273 in Docket No. 74680-CI, Order No. 10093 in Docket No. 810001-EU, and Commission Directives of April 24 and April 30, 1980, hereby petitions this Commission to approve the proposed Generation Performance Incentive Factor (GPIF) targets of 89.4% for weighted system equivalent availability and 9187 BTU/kWh for weighted system average net operating heat rate January 2002 through December 2002. FPL also petitions this Commission to approve the proposed estimated benchmark level of \$37,870,079 for 2002 for gains on non-separated wholesale energy sales eligible for a shareholder incentive. FPL petitions that the Commission approve the proposals and requests set forth in this petition. In support of this Petition, FPL states:

1. The GPIF targets for the period January 2002 through December 2002 are calculated in accordance with the methodology which is contained in the Generating Performance Incentive Factor Implementation Manual adopted by Order No. 010168 in Docket No. 810001-EU and as revised by Order No. 10912 entered in Docket No. 820001-EU on June 22, 1982.

2. FPL proposes an estimated benchmark level for 2002 for gains on nonseparated wholesale energy sales eligible for a shareholder incentive of \$37,870,079. This three year average threshold includes actual gains for 1999, 2000 and January through July 2001 and estimated for August through December 2001. Gains or sales in 2002 are to be measured against this three year average threshold, after it has been adjusted with the true up filing in April 2002 to include all actual data for the year 2001.

WHEREFORE, FPL respectfully requests this Commission to approve the GPIF targets and the estimated benchmark level for gains on non-separated wholesale energy sales eligible for a shareholder incentive for the period January 2002 through December 2002 requested herein.

Finally, FPL requests approval of all of the proposals and requests set forth in this petition.
