**IDS TELCOM'S REQUEST FOR SPECIFIED
CONFIDENTIAL CLASSIFICATION**

Comes now, IDS Long Distance, Inc. n/k/a IDS Telcom, LLC ("IDS") and pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, files its Request for Specified Confidential Classification, and states the following:

1. IDS is filing a Request for Confidential Classification for Late Filed Deposition Exhibit No. 1 to the Deposition of Keith Kramer and Rebuttal Testimony Exhibit KK-23 to the Rebuttal Testimony of Keith Kramer.

2. Late Filed Deposition Exhibit No. 1 contains proprietary confidential business information pursuant to Section 364.183(3), Florida Statutes. Disclosure of the information would cause harm to IDS' business operations and would impair the competitive business of IDS. Exhibit KK-23 to Keith Kramer's Rebuttal Testimony contains customer proprietary information which is clearly confidential and proprietary under Florida Statutes, Sections 364.183 and 364.24. Accordingly, the exhibit should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

3. IDS has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.

This confidentiality request was filed by or for a "telco" for DN 11846-01. No ruling is required unless the material is subject to a request per 119.07, FS, or is admitted in the record per Rule 25-22.006(8)(b), FAC.
