Dear Mr. Wong:

As we discussed on May 17th, the Commission had previously received two applications from you for pay telephone certificates. Certificate No. 7198 was granted with an effective date of November 12, 1999, in the name of Edward L. Wong. In addition, Certificate No. 7361 was granted with an effective date of March 17, 2000, in the name of Edward Wong. This was discovered after dockets were established for nonpayment of the Regulatory Assessment Fee (RAF) for both certificates.

After your phone call to me on May 17, 2001, I explained that the Commission would vacate the Order granting Certificate No. 7361 and that you would not owe the RAF for that certificate. That has now been accomplished and we can go forward with Docket No. 010589-TC.

You had told me in the May 17th conversation that you were no longer in the pay telephone business and that the person you invested with had filed for bankruptcy. Since you do not want to keep Certificate No. 7198 active and in order to resolve Docket No. 010589-TC, you need to write the Commission a letter requesting cancellation of Certificate No. 7198 and paying the 2000 RAF. In addition, the 2001 RAF needs to be paid or you need to provide a date certain the 2001 RAF will be paid. Both RAF return forms are enclosed, along with a breakdown of the past due amount.
