

**AMENDMENT TO PETITION OF TAMPA ELECTRIC COMPANY**


Tampa Electric Company ("Tampa Electric" or "the company"), hereby amends the Petition it filed in this proceeding on September 20, 2001 as follows:

1. In Paragraph No. 2 of its September 20, 2001 Petition, Tampa Electric identified its estimated/actual true-up amount for the January 2001 through December 2001 period to be an overrecovery of \$33,224. That amount was in error by \$302 and should have read \$33,526.
2. Tampa Electric reaffirms its September 20, 2001 Petition in all other respects.


