Nonnye has brought to my attention a typographical error in a prior Order that is going to affect a current docket's processing.

The above docket is going to be affected by what appears to have been an initial Certification typographical error in the Order issued for IXC Certification in Docket 920161-TI. Nonnye tells me that since the Order was issued with the typo, she can't correct MCD and it will probably affect the Case Mgmt. change as well.

The Company name according to the Secretary of State is WORKING ASSETS FUNDING SERVICES, INC. with an "S" on the end of Services (See below). This company was registered with the Sec of State as of 7/15/1991 which is prior to the Regulation Date of 6/17/92. It is obvious this is a PSC staff clerical error by leaving the "S" off the name in the Order.

Is this an error that can be corrected Administratively by Staff and rather quickly, without involving the Company so I can process Docket 011171-TI's Consent Recommendation on 10/4/01? This company has contacted Staff and requested that we try and process their Reorganization request for this next Agenda. I don't want to delay this Company's current docket's processing because Staff made a clerical error in 1992.
