5) The resulting net total projected conservation costs to be recovered for the period

January 2002 through December 2002 are \$252,898 for the Marianna division and \$264,775 for the

Fernandina Beach division. Based upon projected sales for each respective division the appropriate

levelized conservation cost recovery factors for the period January 2002 through December 2002 are

\$,00084 for the Marianna division and \$,00058 for the Fernandina Beach division.
