As you may be aware, Comcast MH Telephony Communications of Florida, Inc. and its affiliates have discontinued regional toll and long distance services in Florida. Accordingly, at this time Comcast is seeking the cancellation of Certificate No. 3118. The certificate cancellation became necessary due to a change in the company's business plan. That change resulted in the discontinuance of regional toll and long distance services to Comcast South Florida customers. Pursuant to 25-24.820(2), F.A.C., Comcast represents that it has previously paid to the FPSC any regulatory assessment fees required for calendar year 2000 and will pay the fees incurred during the first six months of 2001.

Attached herewith please find a sample copy of the Individual Customer Notice regarding the discontinuance of service. Comcast did not require its customers to submit a deposit prior to receiving service. Consequently, there will be no issues related to treatment of customer deposits. At this time there are no active customers and final bills have been submitted and payment is expected for such bills.
