On behalf of Vista International Communications, Inc. ("Vista"), this letter notifies the Commission that Vista hereby surrenders its Telephone Certificate of Public Convenience and Necessity, No. 3554, granted by Commission Order No. PSC-94-0505-FOF-TI (May 20, 1994) ("Certificate"). In addition, Vista hereby withdraws and cancels its tariff currently on file with the Commission.

Vista does not currently serve any customers in the State of Florida and, due to changes in its business plans, desires to cease offering intrastate telecommunications services in Florida. Because Vista does not currently serve any customers in Florida, Vista respectfully submits that the surrender of its Certificate and withdrawal of its tariff is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.

It is Vista's understanding that the Commission may require the return of Certificate No. 3554. In lieu of returning the original Certificate, attached hereto please find a copy of Vista's Certificate. Despite Vista's best efforts, it has been unable to locate the original Certificate among its records.
