This letter is being sent to propose a settlement offer regarding the Interexchange Company Regulatory Assessment Fee Return for the year ended December 31, 2000, on behalf of Futur Telecom America, Inc.

In response to the CASR initiated (a copy which is provided as Attachment A), Futur Telecom America, Inc. provides the following information:

Proposed Settlement

Proposed Settlement: The Company offers the Florida Public Service Commission (FPSC) a pledge to file all Regulatory Assessment Fee Returns for all certification types by the due date and a settlement offer of \$100 to compensate the FPSC for opening a docket in exchange for the FPSC restoring the Company to good standing with the FPSC and immediately closing docket #011098-TS without further action taken against the Company.

A check for the Past Due Amount in full: A copy of Futur Telecom's \$67.00 check (check #2819 dated 10/4/01) for payment in full of the Interexchange Company Regulatory Assessment Fee Return is included in Attachment B along with a copy of the return which is also being filed in conjunction with this request.

Statement: Futur Telecom states that it has taken steps to prevent future late payments of the regulatory assessment fees.



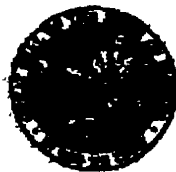

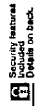
