In response to Ms. Paula Isler's letter regarding Glyphics nonpayment of the 2000 Regulatory Assessment Fee, we are submitting the following proposed settlement:

- 1) Docket number: 011028-TI
Glyphics Communications, Inc.
- 2) A check for the past due amount in full was sent to the Commission on September 7, 2001. The check was in the amount of \$395.55. Also, the Regulatory Assessment Fee Return was sent at the same time.
- 3) The company has retained a regulatory consulting company to assist them with future regulatory filings, including the Interexchange Company Regulatory Assessment Fee Return. Therefore, the company believes all future regulatory filings will be filed in accordance with Commission rules.
- 4) The company agrees to waive any objection to the administrative cancellation of its certificate should it fail to pay in accordance with its settlement offer. If, however, there is a factual dispute as to the manner or level of compliance with any provision in the settlement, Commission staff will bring the matter to the Commission for consideration.
- 5) The company proposes a \$100 monetary settlement for the delinquency of its Interexchange Regulatory Assessment Fee Return.


