1. About the LCSC Order Tracking Application

1.1 Development Platform

This application was developed using the NewEra Windowpainter Version 1.02.UC1 and the NewEra 4gl language.

1.2 General Description

This product was designed to provide a graphical user interface to the LCSC Order Tracking tables in order to track service requests through the LCSC.

1.3 To Start the LCSC Order Tracking Application.

The LCSCs will access the LCSC Order Tracking Application through a desktop icon. Activation will take the user to the "LON" Screen.

2. LON Processing

2.1 General Information

LON is the application used in the LCSC to track LSRs (Local Service Requests) by assigning a LON (Local Order Number). It is a GUI (Graphic User Interface) to the LCSC Order Tracking tables which store the records of LSR's that are processed through LCSC. The LON Screen is accessed through the [Order Tracking] icon and the LCSC Order Tracking Grids are accessed through the [LOIS] icon on the Exceed Desktop. LON is an intracompany application developed using NewEra Windowpainter Version 1.02.UCI and the New Era 4gl language. LON is being improved and updated as the business requirements and user suggestions dictate. Requests for modification may be submitted through the

3.1.1 Description

This is the screen first accessed by launching the application. This window displays fields for viewing, updating or input of information relating to basic LSR information and status and for accessing other screens in the Order Tracking application.

3.1.2 Fields in the LON Screen

Field	Description
LON	Local Order Number assigned by the computer upon input
PON	Purchase Order Number assigned by the initiator.
VER	Version Number of LSR
State	State in which service is requested.
IMAGE	Image number.
MECH	Marking "Y" indicates that the LSR fell out of a mechanized system.
REQTYP	Two Drop down list boxes listing valid type categories corresponding to REQTYP fields on the request form.
ACT	A Drop down list box listing valid type categories corresponding to the ACT field on the request form.
SUP	A Drop down list box listing valid type categories corresponding to the SUP field on the request form.
EXP	A Drop down list box listing valid type categories corresponding to the EXP field on the request form.
CC (OCN)	The Company Code (Operating Company Number) of the company initiating the order.
TOS	Type of Service is a 3 digit code. The first of the three list boxes has the customer type choices, the second has the service type choices and the third has the billing type choices. Required field that must be BBR compliant.
DQTY	Disconnect Quantity
RQTY	Resale Quantity

Field	Description
Project #	Free form text enter for the Project Number Associated with the LSR.
Group	Drop down list of groups in the center. List maintained by center.
Sales Code	Sales Code of the service representative who is handling the LSR
Remarks	Free form text enter for user notes.
Received	Date and time LSR is received. Must be input in yyyy-mm-dd hh:mm format and must be within 10 minutes of system time.
In Clarif Ind	Auto filled by the system to indicate a clarification is pending on the LSR.
Cancelled D/T	Date and time LSR was placed into "Cancelled" status. Populated with the current date and time when the SUP is set to)or 1.
FOC	Date and time the latest FOC was transmitted for the LSR. Posted by system when "Manual FOC" posted or FOC is transmitted.
First Received	Date and time of the first receipt of the LSR posted. Auto populated by the system when a LON is first posted.
First Clarification	Date and time LSR was first placed into "In Clarification" status. Auto populated by the system when the first clarification is transmitted.
Rejected	Date and time LSR was "Rejected". Auto populated by the system when the Rejection Notice is transmitted.
Handled	Date and time LSR which was marked as MECH was first placed into "In Clarification" status. Auto populated by the system when the clarification is logged.

Field	Description
RPON	Related PON. A single PON entry field for "chaining" related PONs.
PF	A "Y" in this field indicates a PF exists for an order on this LSR.
MA	A "Y" in this field indicates a MA exists for an order on this LSR.
JEOPARDY	Date and Time PON placed into Jeopardy status. Auto populated by the system when the jeopardy logged.

3.1.3 Buttons in LON Screen

The title for each section indicates the Label of the button in this section followed by the "Quick key" equivalent. Use the mouse cursor to section a button function or use the "Quick key" equivalent for keyboard navigating.

3.1.3.1 New Query (SHIFT+F1)

Prepares the fields in this section to accept query criteria. After selecting this button, input criteria (see QBE section) then select the Retrieve button to view the results.

3.1.3.2 Retrieve (SHIFT+F2)

Searches the database for records in accordance with the criteria in this section. If no criteria is specified, then Retrieve attempts to return ALL records. Returned records are then available for editing.

3.1.3.3 New LON (SHIFT+F3)

Creates a new line for input of a new LSRs data in the LON Table Section. Type data into the fields in this section and use the Apply button in this section to write the record into the database. The LON field is not accessible for input because this number is assigned by the database.

3.1.3.4 Clone LON (SHIFT+F4)

Creates a new line for input of a new LSRs data in the LON Table Section and pre-populates fields with the data in currently viewed record except the lon, pon, foc date, cancel date, first received, first clarification, timestamp and clarification Indicator. Type data into the fields or edit fields in this section

3.1.3.5 Revert (SHIFT+F5)

Returns a record in this section, which has been modified but not applied to its values prior to editing.

3.1.3.6 Apply (SHIFT+F6)

Writes a "New" or Updated record to the LON table of the database.

3.1.3.7 Next LON and Previous LON (SHIFT+F7) and (SHIFT+F8)

When more than one record is Retrieved the Next and Previous LON buttons are used to move from record to record. If a record has been modified and the user requests traversal to another record a message box will prompt the user as to whether or not the changes should be applied to the database.

3.1.3.8 Orders(SHIFT+F9)

Displays the ORDERS screen for the LON currently displayed in the LON Table section. If there are no existing orders the message "No existing Orders for this LON" appears near the bottom of the ORDERS screen.

3.1.3.9 Clarification(Control+F9)

Displays the Clarification screen for the LON currently displayed in the LON Table section if MECH is not marked "Y". If MECH is marked "Y", then a message box will warn the user and allow posting of a log entry and posting of a "Handled" date. (MECH order clarifications are not to be faxed but are sent through the mechanized system and require no more manual action unless the next version falls out.)

3.1.3.10 Jeopardy

Displays the Jeopardy notification screen for the LON currently displayed in the LON Table section if MECH is not marked "Y". If MECH is marked "Y", then a message box will warn the user and allow posting of a log entry and posting of a "Handled" date. (MECH order jeopardy notifications are not to be faxed but are sent through the mechanized system and require no more manual action unless the next version falls out.)

3.1.3.11 Reject(Shift+Control+F5)

Displays the Reject screen for the LON currently displayed in the LON Table section.

3.1.3.12 Close Button

Closes this window.

3.1.3.13 Quick Telephone Entry (CONTROL+T)

NO VISIBLE BUTTON. This quick key pops up a box for entry of a telephone number associated with the LON and enters it in the ORDER table without accessing the ORDERS section

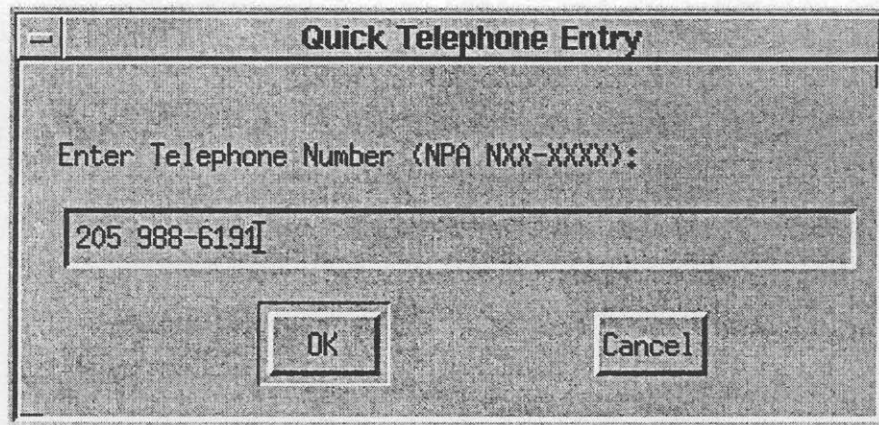


Figure 3 "Quick Telephone Entry" Pop Up

3.2.3.3 New Order (F3)

3.2.3.4 Clone Order (F4)

Makes a "clone" of the order record currently in view in the Order Table section to be modified and applied. The service order number must be changed or the database will not allow the new record to be applied.

3.2.3.5 Revert (F5)

Returns a record in this section which has been modified but not applied to its values prior to editing.

3.2.3.6 Apply (F6)

Writes a "New" or Updated record to the Order Table.

3.2.3.7 Next Order and Previous Order (F7) and (F8)

3.2.3.8 View LON for this Order (F9)

3.2.3.9 POST FOC (F10)

Accesses the FOC screen for LONs which do not have the MECH Indicator set. Posts a "Manual FOC" for those which do have the MECH Indicator set.

3.2.3.10 Manual FOC (F11)

Posts the FOC Date time or logs a "REFOC" without accessing the FOC screen or transmitting a FOC through the application.

3.2.3.11 Return to log (F12)

Returns to the LON screen without a new query of the LON.

- Clar-Resend Ctrl+F11 (active when viewing Clarification Screen)
- Clar-Remove Clarification Ctrl+F4 (active when viewing Clarification Screen)
- Clar-Return Ctrl+F12 (active when viewing Clarification Screen)

Contains a list of "Quick key" equivalents to the buttons in the FOC screen. Buttons functions can be activated by selecting the menu item. Availability of the functions may be dependent on the screen currently in view. Menu items are:

- Clar-New Ctrl+F3 (active when viewing FOC Screen)
- Clar-Send Ctrl+F10 (active when viewing FOC Screen)
- Clar-Resend Ctrl+F11 (active when viewing FOC Screen)

- Clar-View LON Ctrl+F9 (active when viewing FOC Screen)
- Clar-Return to log Ctrl+F12 (active when viewing FOC Screen)

Contains a list of "Quick key" equivalents to the buttons in the Reject screen. Buttons functions can be activated by selecting the menu item. Availability of the functions may be dependent on the screen currently in view. Menu items are:

- REJ-Send Shift+Ctrl+F5 (active when viewing REJ Screen)
- REJ-Resend Shift+Ctrl+F6 (active when viewing REJ Screen)
- REJ-View LON Shift+Ctrl+F7 (active when viewing REJ Screen)
- REJ-BackToLONShift+Ctrl+F8 (active when viewing REJ Screen)

3.7.7 JEP menu

Contains a list of "Quick key" equivalents to the buttons in the jeopardy notification screen. Buttons functions can be activated by selecting the menu item. Availability of the functions may be dependent on the screen currently in view. Menu items are:

- Jep-New Ctrl+F2 (active when viewing Jeopardy Screen)
- Jep-Send Ctrl+F6 (active when viewing Jeopardy Screen)
- Jep-Resend Ctrl+F7 (active when viewing Jeopardy Screen)
- Jep-Remove Jeopardy Ctrl+F5 (active when viewing Jeopardy Screen)
- Jep-Return Ctrl+F8 (active when viewing Jeopardy Screen)

3.7.8 Help menu

Query Help - describes the operators available in Query By Example mode.

Field Descriptions- describes each entry field in the LON, ORD, CLR, FOC screens.

About- provides information about the application's current version.

4. Receipt of the Manually Submitted LSRs

4.1 General Information about LSRs

Manual LSRs (Local Service Request) are requests for local service sent by a CLEC to the LCSC by a means other than an electronic interface. These paper LSRs must be manually handled and tracked. As of September 15, 2000, all manual LSRs must be faxed to the LCSC. Alternate method of receipt for individual LSRs greater than 100 pages must be pre-arranged by the CLEC with Center management. Assigned clerks are responsible for monitoring the Fax Server printers. It is the responsibility of the Clerical group to:

- Receive and collect the LSRs
- Sort the LSRs
- Input into LON
- Distribute to the Supervisor groups or Service Representative

This must be done in a timely manner so that a Service Order can be issued and the FOC sent.

Additional information about fields and components that make up an LSR can be found in the .

4.2 Facsimile LSRs

Facsimile (FAX) LSRs are received in the LCSC through the FAX Server that routes them to a printer. The FAX Server retains an image of each LSR, which is archived for 3 years.

4.3 Courier or Overnight LSRs

As of September 15, 2000, all manually received LSRs must be received via fax. CLECs cannot mail or courier LSRs without prior arrangement with center management. CLECs were notified of this change in a Carrier Notification Letter posted on the web August 9, 2000. If center management has agreed to receive an LSR via US mail, they must be opened, sorted, date stamped, and delivered to the LON screening desk by the Clerk. Paper LSRs that are not received by fax must be kept in a file for 3 years.

4.4 US Mail LSRs

As of September 15, 2000, all manually received LSRs must be received via fax. CLECs cannot mail or courier LSRs without prior arrangement with center management. CLECs were notified of this change in a Carrier Notification Letter posted on the web August 9, 2000. If center management has agreed to receive an LSR via US mail, they must be opened, sorted, date stamped, and delivered to the LON screening desk by the Clerk. Paper LSRs that are not received by fax must be kept in a file for 3 years.

4.5 LEO fallouts

Some CLECs send LSRs electronically through LENS and EDI. If the electronic LSR does not flow through LEO and LESOG because of errors or eligibility, it drops out into a queue for manual handling. A Service Representative must access LEO and claim these LSRs and fix the errors or issue a Service Order. When a Service Rep claims a LSR in LEO, the LSR must be logged into LON by the Service Representative in order for productivity credit to be given. These LSRs are marked in Order Tracker as mechanized fallout by the presence of a "Y" in the MECH field. This indicator prevents a fax transmission from being delivered.

4.6 Distribution of LSRs

- LSRs are gathered from the Fax Server printers in a timely manner
- LSRs are sorted and collated
- LSRs are stapled and Date Stamped, if needed (LOIS automatically time stamps LSRs)
- LSRs are delivered to LON desk by the Sorting Clerk

Additional information about LSRs and how they are handled in Atlanta and Birmingham can be found at

5. Screening of the LSR

5.1 Screening of LSR for Reject Reasons

The LSR is scanned by the LON clerk visually for obvious errors. That includes legibility and completion of required fields. Below is a check list of the required fields that must be completed before the LSR is entered into the [Order Tracking] LON database.

- Is the LSR a valid LSOG form and version ?
- Legibility, can you read all the information?

Note: You may need to check the image in LOIS before rejecting.

- Does the LSR have all the pages required?

Note: You may need to check the image in LOIS before rejecting.

- Are the required fields on the LSR completed? All of these fields, except where noted, are on the first page of the LSR.
 - PON number, the Purchase Order number. Is there a PON number? Is the PON number the same on all pages of the LSR? Is the PON number correctly formatted? A PON number can be up to 16 characters. If the LSR is an LSOG version 2 form, the PON may contain any letters, numbers or characters. If the LSR is an LSOG version 4 form, the only valid entries are:
 - Upper Case alpha (A - Z)
 - Numeric (0 - 9)
 - Symbols, limited to:
 - period (.)
 - comma (,)
 - hyphen (-)
 - apostrophe (')
 - VER, if it is a supplemental LSR
 - STATE, location where the end user is requesting the service (On the 1st page of the End User information section of the LSR)
 - REQ TYP
 - ACT
 - SUP, if it is a supplemental LSR. **The SUP is required if the VER field is populated. Manual LSR's must contain a SUP value of 1,2, or 3. Any manual LSR not meeting this criteria will be rejected.**

- CC, this must be a valide Company Code; a Carrier Identification Code (CIC) is prohibited in this field.
- TOS, this must be populated and valid in order to be accepted by LON. Clerical personnel will reject any LSR that is missing or has an incorrect TOS (the TOS must contain at least three characters).
- DQTY, this field is required if the DISC # field is populated or if the ACT field is a "W". (On the 2nd page of the End User Information section of the LSR)
 - If the DISC # field has a telephone number in it, the DQTY field shows the quantity of telephone numbers being disconnected and this number is copied to the DQTY field on the LON Screen.
 - When the ACT field is a "W" it [DQTY] indicates the quantity of telephone numbers being converted because the Resale Form section of the LSR is not sent on a W (Switch as is) request. This number is copied to the RQTY field on the LON Screen.
- RSQTY (On the 1st page of the Resale Service section of the LSR).
- INIT FAX NO is located in the contact fields section and is required on all manually processed orders. Any manual LSR not containing this information will be rejected. SEE SPECIAL INSTRUCTIONS FOR REJECTING AN LSR!!!

If any of these fields are missing or incorrect, the LSR should be Rejected. See the section of this document called Rejects for instructions on how to Reject an LSR.

Other possible reasons for an LSR to be rejected include:

- The PON and version have already been received.
- The PON for this CC has already been received, is FOC'd and the due date of the Order on the Order Screen is past due. (Unless the PF or MA indicator boxes are marked with a "Y".)
- The PON for this CC has already been received and is Cancelled.
- The LSR has a version number and/or SUP reason code but is this is the first receipt of the LSR.
- PG__of__ Page of field in the administration field of the LSR should be reviewed to ensure all relevant pages have been received. The LSR will be rejected if all pages indicated are not present.

If any of these fields are missing or incorrect, the LSR should be Rejected. See the section of this document called Rejects for instructions on how to Reject an LSR.

5.2 Rejecting an LSR

When it is determined that an LSR needs to be rejected, LON in as much data as you can into Order Tracker and then select the Reject button. This will take you to the Reject Screen. Fill out the faxing information at the top of the screen, pick a reject reason(s) and select the Send button. This will LON

in the Reject and send the reject notice to the customer via the fax server. **THE INIT FAX NO IS THE ONLY NUMBER THAT WILL BE USED FOR SENDING A REJECT ON A MANUAL LSR! Manual LSR's without an INIT FAX NO will be immediately rejected and no further processing of the LSR will occur.**

LSRs may still be manually rejected when necessary (such as the minimal required data of PON, CC, Date/Time Received, and Image information are not available, or if Order Tracker is down. These should be maintained in a reject file.

5.3 LSRs from Suspended CLECs

These are CLECs from whom we are not accepting LSRs because of billing disputes. They are suspended upon request from the Billing Group. The system does not allow a LSR to be entered into LON from a suspended CLEC. The CC_stop table prevents it.

Handling of LSRs from suspended CLECs

- When you attempt to LON in a PON or version of a supplemental PON and receive the message that we are not accepting this CLEC's LSRs, select the reject button. This will take you to the Reject Screen. Choose the reject reason of "Due to continued past due balances, we are no longer provisioning your service orders. If you have any questions, please contact the Billing Representative within your company" and then hit send.
- Order Tracker will provide you a LON number for this LSR. For retention purposes, treat it in the same manner as any other LSR.

6. Screening Complex LSR's by the UNE Group

6.1 Procedures for UNE Clerical Group

When manual LSR's are received by the UNE clerical group, it is their responsibility to determine if the LSR is Complex or UNE.

Listed below are the steps this group will follow:

- Check for ATN
- Go to BOCRIS for CSR
- Go to the LSI for summary screen

If the account is NOT Complex ...	If the account IS Complex ...
The LSR will be loaded into LON.	The LSR should be rejected.

To determine if the account is Complex, the clerk will review the LSI for:

7. Entering a PON into Order Tracker

7.1 Querying Order Tracker for a PON

After entering [Order Tracking] by clicking the icon on the Exceed desktop, you are in the Query mode on the LON screen. (The cursor is in the LON field in the Query mode.) A check must be made to determine if the LSR is a duplicate or a .

Tab to the PON field and enter the PON number and then Tab to the CC field and enter the Company Code; push Retrieve with the mouse pointer or Shift F-2 on the keyboard.

If a dialog box appears saying the CC is not allowed, this means that the Company Code appears on in the cc_stop table. This table contains a listing of CC's (Company Code) for companies whose work we are not currently processing new LSRs (usually for billing reasons). This table is maintained by a manager in your center.

When any new LON record is created, Order Tracker will check this table. If that CC appears in the table an error message box will appear and display the reason and the name of the person who posted the entry into the table. In case of a problem concerning the particular Company Code you have tried to enter, you may contact that individual to clarify. Notify management that you have a LSR that is on the CC stop list and you can not process it.

7.2 Entering information into LON

To enter a new LSR into LON, depress the New LON button or [Shift F-3] on the Keyboard. When the New LON screen is accessed the cursor will be in the PON field. This is the second field on the screen and allows data entry. The first field is the LON field which is populated automatically by the system after information from the LSR is entered and [Apply] is clicked. The ACT, REQ TYP, DQTY, R(S)QTY, and TOS fields on the LON screen must be populated from the paper LSR. The fields were optional in the past, but are now required input. These fields are conditional/required on the LSR form per OBF (Ordering and Billing Forum) guidelines. If there is not sufficient information in these fields for the type of Service Order being requested on the LSR, the LSR must be Clarified or Rejected back to the CLEC to populate these fields. The information from these fields provide more precise data to the LON database, to assist with the quantity results and data for reports.

The steps for entering an LSR into the LON database are:

1. PON field; Enter the PON number.
2. VER field; Enter the VER (version) number if it is a supplemental LSR.

Note: The first time a CLEC sends an LSR, the version field should be blank. If the version field is populated on the first copy received, reject the LSR in Order Tracker. The next version received should have a version number beginning with 01 and for every receipt thereafter, the version number should be incremented by one digit.

Note: If the previous received copy of an LSR was rejected, the version should not be incremented. If the CLEC has changed the version number in response to a reject, the PON should be rejected in Order Tracker again.

3. State field: Enter the State, from the End User Information page of the LSR.

Note: The state is required on the End User form. If it is not populated, reject the LSR in Order Tracker.

4. IMAGE field; Enter the IMAGE information. This is the file name of the FAX server image or the vehicle the LSR is received by, FAX, Courier, US Mail.
5. MECH field: If the LSR is claimed from a mechanized system, this is indicated by selecting [Y] on the pull down menu.
6. REQ TYP field; Enter the REQ TYP from the REQ TYP information of the LSR.

Note: This field is required on an LSR. If the LSR does not have a valid REQ TYP, reject it in Order Tracker.

7. ACT field; Enter the ACT information.

Note: This field is required on an LSR. If the LSR does not have a valid ACT, reject it in Order Tracker.

8. SUP field; If this is a supplemental LSR then it should have a SUP code and it should be entered from the pull down menu.

Note: The SUP is required if the version field is populated. If the SUP field does not have a valid entry of 01, 02 or 03, and the version field is populated, reject the LSR in Order Tracker.

9. EXP field; If the EXP (Expedite) box is checked on the LSR, enter [Y] on the Pull down menu in the EXP field.
10. CC field; Enter the CC code from the LSR.

Note: The Company Code entered into this field must be valid in the OCN table in Order Tracker. This table is maintained by a management person in the center. Should you encounter the error message "Not allowed because there is no matching entry in the ocn table. Contact Center Support Manager to add the OCN if it is valid" make sure that you have typed the CC (Company Code) just as it appears on the LSR. If you have typed it correctly, refer the LSR to your Center Support Manager or supervisor. This error indicates that the CC that you are trying to input into Order Tracker isn't in the table (OCN table) that Order Tracker checks for valid CC's.

11. TOS 1 field; Select the entry from the pull down menu that corresponds with the entry in the first field of the TOS information of the LSR.
12. TOS 2 field; Select the entry from the pull down menu that corresponds with the entry in the second field of the TOS information of the LSR.
13. TOS 3 field; Select the entry from the pull down menu that corresponds with the entry in the third field of the TOS information of the LSR.
14. DQTY field; Enter the quantity from the DQTY field on the 2nd page of the End User Information sheet of the LSR, if the DISC # field is populated.
15. RQTY field; Enter the information from the RSQTY (Resale Quantity) field of the Resale Service section of the LSR. This is the quantity of telephone numbers connected by this LSR, or When the ACT field is a "W" the RSQTY (quantity to be converted) will be found in the End User information section of the LSR under the DQTY field because the Resale Form section of the LSR is not sent on a W (Switch as is) request.
16. If the RPON field on the LSR is populated, enter that data into the RPON field in Order Tracker.
17. Project # field; If the LSR is part of a project, enter the Project number.
18. Group field; Enter the group the LSR is to be routed to.
19. SC field; Enter the Sales Code of the Service Rep assigned or working on this LSR.
20. Remarks field; Enter any additional information concerning this LSR.

21. Received field; Enter the received time from the fax time on the LSR or the date stamp put on those without a fax time. The application will not allow you to enter a date more than 7 days in the past.
22. If the ATN field on the LSR is populated, press the Control <Ctrl> key and the letter “t” key at the same time. This will allow you to enter the telephone number into Order Tracker. When you press <Enter>, the record will be created and a LON number returned. Write the LON number and your initials in red on the top front of the paper LSR package and distribute the LSRs to the appropriate group or manager.
23. If the ATN field is blank, click the [Apply] button with the mouse pointer or [Shift F-6] on the Keyboard. LON gives the LSR a LON number and the LSR is entered into the database. Write the LON number and your initials in red on the top front of the paper LSR package and distribute the LSRs to the appropriate group or manager.

Additional information:

- To change the Cancelled date on a LON record a new Received date must be posted. When a new Received date is posted it removes the existing Cancelled date. You must then populate the SUP field with 0 or 1 to post the current date as the Cancelled date.
- The FOC date field on the LON screen can not be edited. The FOC date and time is inserted by the application when a FOC is sent.

Helpful Hints in entering an LSR into LON:

- If entering a large quantity of LSRs with the same information, use the [Clone LON] button or [Shift F-4] and LON will duplicate the information from the currently viewed LSR except the LON and PON fields.
- The Help selection in the menu at the top of the window gives help on Queries and an explanation of all fields in LON

8. Entering an LSR into the LNP Gateway

8.1 If the LSR has an NPT of D

If the NPT field on the LSR is populated with “D”, the LSR must be input into the LNP Gateway.

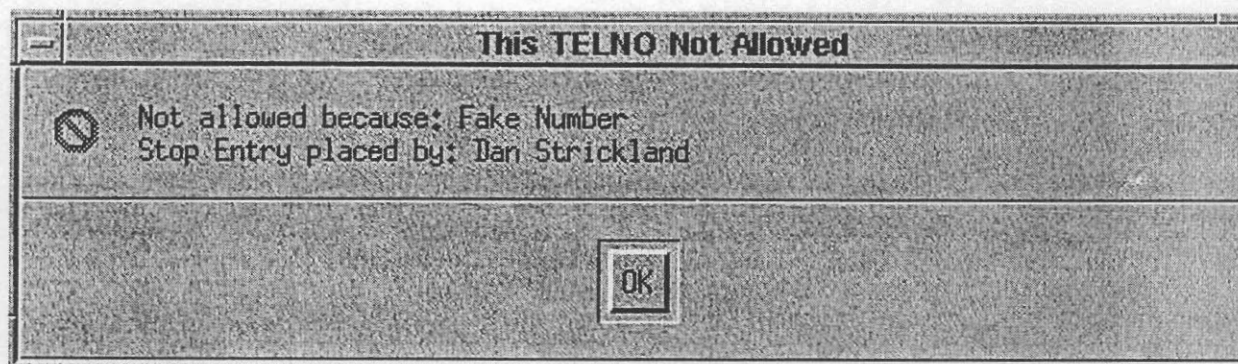
9. Clarifications

9.1 Sending a Clarification From LON

The Clarification answer from the CLEC must include a complete LSR. OBF requires that complete LSRs with incremental version numbers will be accepted as appropriate responses to Clarification Requests. The Service Reps must have complete information to build a Service Order. Additional information concerning clarifications can be found in the Resale procedures guide on

Note: THE INIT FAX NO IS THE ONLY NUMBER THAT WILL BE USED FOR SENDING A CLARIFICATION ON A MANUAL LSR!

- To Send the first Clarification:
 - Key in the To Name: field
 - Key in the From SB Rep: field (In Atlanta, put Atlanta)
 - Key in the Contact Number: field
 - Choose at least one of the Clarification Reasons from the pull down menu
 - To choose multiple reasons hold down the [Ctrl] key and point and click the multiple reasons
 - —
 - Enter any comments that might help resolve the conflict, up to 255 characters, in the Comments field
 - Click Send or [Ctrl] F-10 on the keyboard to send the Clarification request
- If the MECH indicator is set to "Y" when the LSR is entered into LON and the Clarification button is activated, then a message box will give the user the choice to make a log entry and put the LSR in handled status or to cancel out of the dialog box. This allows the Rep credit for a clarification without sending a duplicate clarification to the CLEC from LON.
- If you try to fax to a telephone number that is in the table tn_stop, which is a listing of Telephone numbers that the center does not wish to allow faxes to be sent by the Clarification or FOC send functions (annoyance numbers, our own numbers, obsolete numbers, common transpositions etc.). An error message box will display the Reason the entry is not allowed and who placed that telephone number in the table. In case of a problem concerning the telephone number you have tried to enter, you may contact the individual who had the number placed in the table.



9.2 Clarification Fax failures

Clarifications to Order Tracking uses a generic e-mail account to deposit fax failure notices. Enter Open Mail using the following instructions:

- Click Open mail icon
- Click Config...
- Enter User Name: LCSC FAX
- Enter Server: 90.11.244.50
- click OK
- Enter Password: LCSC1 and click Login
- Select View and hold down left mouse button moving bar down to "By Title" and select.
- Highlight (7 or 8) by holding [Ctrl] and clicking the mouse on each title
 - Select YAXQA## to get the Atlanta fax failures
 - Select YAXQB## to get the Birmingham fax failures
- Print selections, making sure all you selected prints
- Delete selections from openmail

Access [Order Tracking] LON to refax the failures.

- Select the [Order Tracking] icon on the Exceed desktop.
- Click [New Query] or [Shift F-1] with the keyboard to access the New Query screen
- Key in the LON number in the LON field
- Click [Retrieve] or [Shift F-2] to start the query
- When the LON record comes up, verify that the PON is still in clarification. If a new version of the PON has been received, ignore the fax failure. If the PON is still in clarification status, Select Clarification

- The Clarification Request screen comes up
- Check the Company Code (CC) on the LON record and match it to the CLEC Default Fax Number list [Birmingham] or the fax number on the LSR in the paper file or the image in LOIS [Atlanta]

Once you have made the appropriate changes, write at the bottom of the printed fax sheet which box the failure occurred in, initial the top of the sheet, and make the changes to the fax # printed on the sheet that you made in the system.

9.3 Clarifications for NC, NCI, and SECNCI (UNE Products)

These fields have been added to the LON application in order to facilitate the accurate identification of certain UNE products. This change took place out of an arising need from the PMAP group to identify certain UNE products.

9.3.1 Data Field Formats

The formats for these fields per the BBR are as follows:

- NC format is 2 alphas followed by 2 alphanumeric or two dashes.
- NCI can be up to 12 characters.
 - First 2 characters are numbers.
 - Third and Fourth characters are alpha.
 - Fifth character is alphanumeric.
- SECNCI format is the same as NCI.

9.3.2 Rules for Required Information

These fields are required for the defined REQ TYP/ACT TYP combinations. **The service representative will clarify the LSR back to the customer if it is not present on the LSR for the specified REQ TYP/ACT TYP.**

For REQ TYP1 = A or B and ACTs of A, N, C, M, T, V, W, P, Q

- NC is always required.
- NCI is required if NC does not begin with TY.
- SECNCI is not required but if SECNCI is given there must be a NCI as well.

9.4 Clarification answer from CLEC

When the CLEC returns the Clarification, the Service Representative will issue the Service Order, close the LSR and send the FOC.

If the CLEC returns the Clarification and it still has a discrepancy, the LSR will stay in Clarification status and another Clarification will be sent to the CLEC

9.5 Cancellation of Clarified LSR's

After 5 days "in clarification," the system sends a notice to the CLEC reminding them why the LSR is "in Clarification."

LON will automatically cancel the LON/LSR record for PONs that have been in Clarification for 14 days (10 business days) without appropriate CLEC response. The system does the following steps.

- Set the SUP field on the LON/LSR record to 0
- Populates the Out of Clarification field to current date/time
- Populates the Cancelled field with the current date/time

To manually cancel an LSR:

By the LCSC for whatever reason:

- Type CANCEL / OLD in [Tel. No.] field.
- Select SUP=0, (0 denotes done by Bell.)
- Select [Apply] [shift+F-6]. Software will populate [D/T Canceled] field with current date and time and LSR is cancelled.

By the CLEC sending a supplementary LSR.

- Rep should type CANCEL in the [Tel. No.] field
- Rep should select SUP=1, (1 denotes done by CLEC)
- Select [Apply] [shift+F-6]. Software will populate [D/T Canceled] field with current date and time and LSR is cancelled.

9.6 To Remove a Clarification

A Clarification status can be removed to allow a LON to be clarified for a new reason or **if the LON was clarified in error.**

To remove a clarification, select the Remove Clarif (cF4) button at the bottom of the clarification screen. Users will receive a warning before the clarification record is removed and a log entry made.

CAUTION

If an LSR is removed from clarification and then subsequently FOC'd, duration will be affected! An LSR should only be removed from clarification if it was originally clarified in error! If the LSR were correctly clarified, the CLEC must send in a supplemental version of the PON to remove the LSR from clarification status.

WARNING

Removing a Clarification causes a LON to appear un-worked in Order Tracker. You must subsequently enter a new Clarification or an FOC.

10. Jeopardy Notifications

10.1 Sending a Jeopardy Notification From LON

A jeopardy occurs when a CLEC provides inaccurate or incomplete information on an LSR that can not be detected prior to a service order being issued and the PON FOC'd. The jeopardy process is applicable to LSR's received via fax or through an electronic interface. At this time, mechanized orders must be sent manually through the LON database. **NOTE: a jeopardy should not be sent when the inaccurate or incomplete information should have been detected during the original screening of the LSR. To do so, is falsifying company records.**

Note: THE INIT FAX NO IS THE ONLY NUMBER THAT WILL BE USED FOR SENDING A JEOPARDY NOTIFICATION ON A MANUAL LSR!

- The following section describes system action when attempting to post a jeopardy. The system action depends on the current LON status of the order.

FOC	Notify user. If OK, JEOP field is populated.
Cancel	Not allowed- user notified.
Reject	Not allowed- user notified.

In Clarification	Not allowed- system suggests user modifies existing clarification and resends OR if appropriate, "Remove" existing clarification and then post Jeopardy.
Jeopardy	No other action allowed except posting a new version. (New "Received" Date and Time)

- To Send the first Jeopardy Notification:
 - Key in the To Name: field
 - Key in the From BST Rep: field (In Atlanta, put Atlanta)
 - Key in the Contact Number: field
 - Choose at least one of the Jeopardy Reasons from the pull down menu
 - To choose multiple reasons hold down the [Ctrl] key and point and click the multiple reasons
 - Enter any comments that might help resolve the conflict, up to 255 characters, in the Comments field
 - Click Send or [Ctrl] F6 on the keyboard to send the Jeopardy notification.

- The service order associated with the PON in jeopardy must be cancelled in SOCS once the jeopardy notice is sent. Any and all related orders must also be cancelled.
- If the MECH indicator is set to "Y" when the LSR is entered into LON and the Jeopardy button is activated, then a message box will give the user the choice to make a log entry and put the LSR in handled status or to cancel out of the dialog box. This allows the Rep credit for a clarification without sending a duplicate clarification to the CLEC from LON.
- If you try to fax to a telephone number that is in the table tn_stop, which is a listing of Telephone numbers that the center does not wish to allow faxes to be sent by the Clarification, FOC, or Jeopardy send functions (annoyance numbers, our own numbers, obsolete numbers, common transpositions etc.). An error message box will display the Reason the entry is not allowed and who placed that telephone number in the table. In case of a problem concerning the telephone number you have tried to enter, you may contact the individual who had the number placed in the table.
- The PON will remain in Jeopardy status until one of the following situations occurs:

Table D Criteria for Removal of Jeopardy Status

A	A SUP LSR is received.
B	The system cancels the PON due to no response from the CLEC. (A follow-up notice is not sent)
C	The jeopardy is removed. (This should only occur if a jeopardy notice was sent in error.)

11. Issuing The Service Order

11.1 DOE and SONGS

A Service Order must be issued through one of two systems. These systems were developed independently by the old Southern Bell and South Central Bell organizations. Orders issued in North Carolina, South Carolina, Georgia, and Florida are in . Orders issued in Kentucky, Tennessee, Alabama, Mississippi, and Louisiana must be issued through SONGS. Information about is in the Resale document.

12. Sending the FOC

12.1 RE-FOC Guidelines

12.1.1 Restrictions

The re-sending of FOC's on the same version is prohibited!!

Note: THE INIT FAX NO IS THE ONLY NUMBER THAT WILL BE USED FOR SENDING AN FOC ON A MANUAL LSR!

12.1.2 Additional CLEC Resources

Should a call be received requesting a re-send of an FOC, the CLEC should be politely informed that we do not resend FOCs, Rejects or Clarifications. The CLEC should also be advised that this information can be obtained from their PON status report on the web, either for manual or electronic orders. Any system outages/problems can be referred to the EC SPOC, the electronic support trouble line, on 1-888-462-8030.

- **PON Status Report for CLECs** - contains a list of manually submitted PONs for a particular RESH code that have been received in the LCSC, FOC'd, Clarified or Rejected, and in Jeopardy status for the past 31 days. This report is updated 5 times per day, Monday-Saturday.
- **Electronic PON Report** - Provides status of information for any PON submitted electronically in the past 10 days via an electronic interface. This report is updated 5 times per day, roughly every 3 hours during the day, Monday-Friday.
- The web site address for CLEC Reports is:

12.1.3 Exception Examples (Not All Inclusive!!)

- Expedites— after approval is received.
- Incorrect data provided on the original FOC.

12.1.4 RE-FOC LON Instructions

To create a "NEW" FOC, Click the "New" button or [Shift+Ctrl+F-3].

- The CURRENT "CC", "PON" and "Version" will be retrieved from the LON record
- The "FOC #" will be incremental by one.
- The "to" and "from" information will be copied from the previous FOC.
- The CURRENT Order information will be displayed in the order section.
- If the LON is currently in FOC status and you click on "New", the system will send new FOC data to the CLEC but the FOC date and time will not be changed.

12.1.5 Additional Service Representative Instructions\Resources

Additional\supplemental information can be viewed in CDIA at the following location: under the section entitled “Requests for resend of FOC, Reject or Clarification on manually submitted LSRs”.

12.2 Closing the LSR in LON

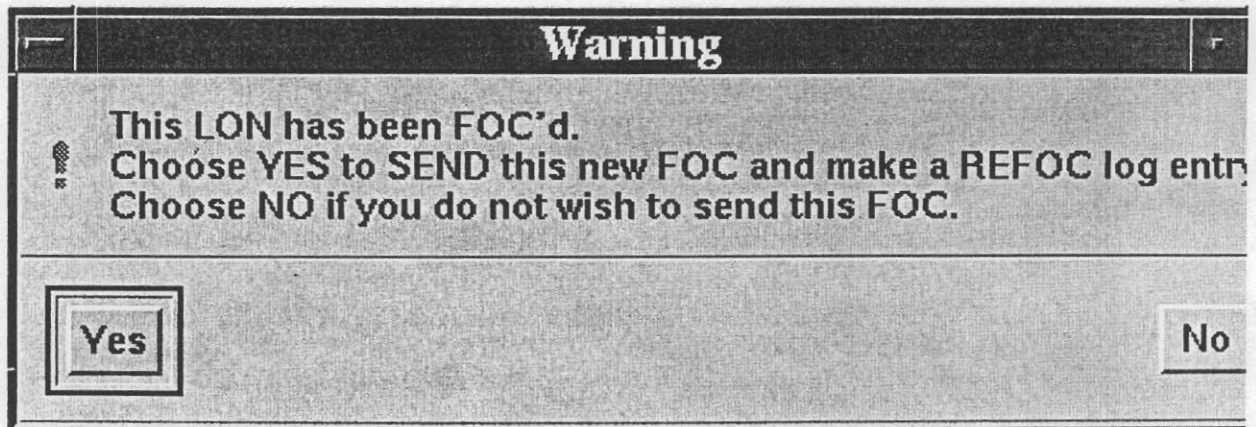
Note: If the LSR you are FOCing is a UNE, be sure to also read the sections below on FOCing SL1s and SL2s.

After issuing the Service Order the LSR must be closed in LON and the FOC sent. The FOC confirms to the CLEC that an order has been issued for the LSR and PON submitted. Click the [Orders] button or [Shift F-9] on the LON screen.

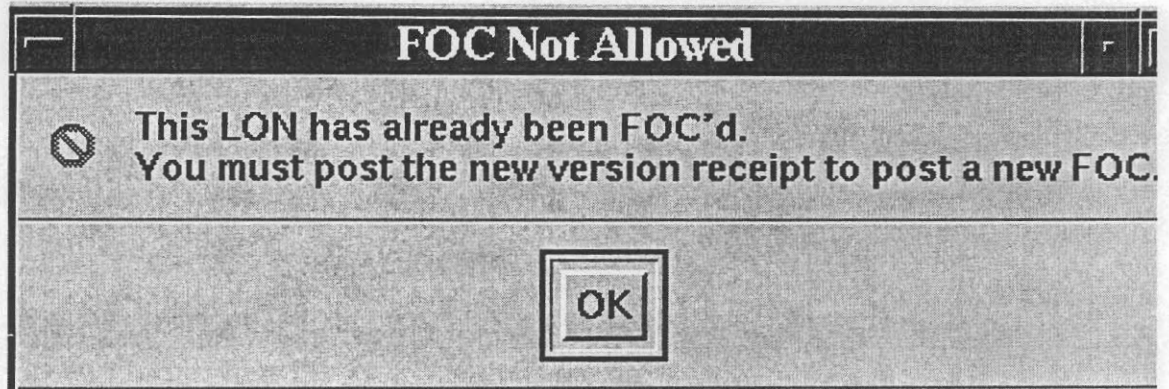
- From the Orders Screen, key in the Service Order Number
- Key the Telephone number or Circuit number in the appropriate field
 - The Telephone number should be in the format: NPA NXX-XXXX

Note: On number changes, the new number is what you will post here.

- Key the Due Date of the Service Order in the appropriate field
 - Click the Post FOC or [F-10] button. If the LON does not have the LEO indicator set to "Y" then the system will take you to the FOC screen. If the PON was marked as Mechanized Fallout, the following window will appear. Choose “Ok” to post an FOC but suppress the output of the FOC to the CLEC. FOCs on mechanized fallout are sent via the mechanized system.
 - If there has not been a FOC previously transmitted, the fields will be empty.



- LON does edits before it will post the FOC. If any of the following statements are true, an error message will be received:
 - The LSR is in Clarification.
 - The LSR has been cancelled
 - The Service Order number is not entered.
 - The Due Date of the Service Order is not entered.
 - The Telephone number or Circuit ID is not entered.
 - The Sales Code is not entered.
 - There has been a previous FOC sent.
- If there is a previous FOC a dialog error box will appear:



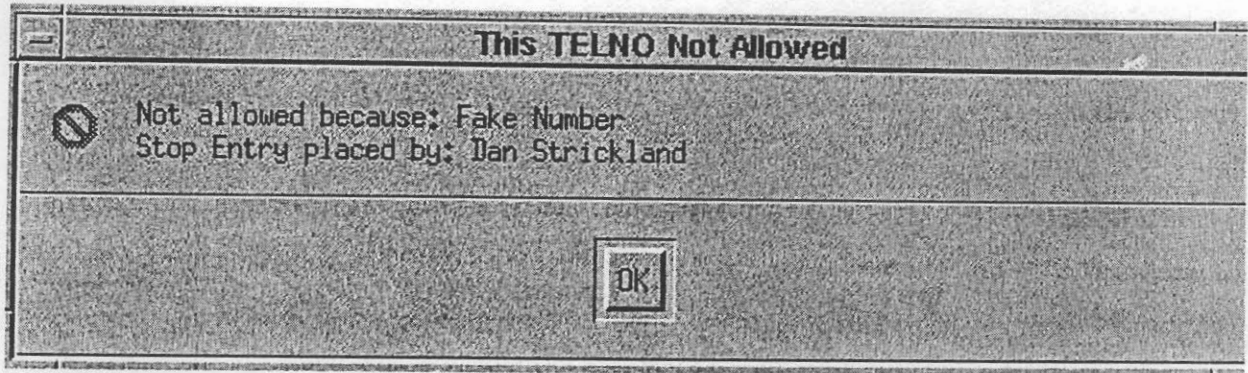
- If all the edits are passed the LSR is FOC'd in LON with a date and time stamp
- The "LON", "CC", "PON" and "Version" will be retrieved from the LON record.
- The "FOC #" will be "1".
- If a Clarification has been sent through the system, the "to" and "from" information will be copied from the most current one as a starting point.
- The Order information as currently exists will be displayed in the order section.
- Edit or enter "To" and "From" information. Enter optional Comments and choose Delivery Type.

Note: Email delivery will only be available if there is an email address for the company in the OCN table.

Click the "Send" button or {Sht, Ctrl F-4}.

- If you try to fax to a telephone number that is in the table tn_stop, which is a listing of Telephone numbers that the center does not wish to allow faxes to be sent by the Clarification or FOC send functions (annoyance numbers, our own numbers, obsolete numbers, common transpositions etc.). An error message box will display the Reason the

entry is not allowed and who placed that telephone number in the table. In case of a problem concerning the telephone number you have tried to enter, you may contact the individual who had the number placed in the table.



- When processing is complete the "Sent" date/time will be populated.
- The "Faxid" is also populated if delivery is FAX.
- If there has been a FOC previously transmitted, that information will be displayed.

Edit "To" and "From" information. Enter optional Comments and choose Delivery Type.

Note: Email delivery will only be available if there is an email address for the company in the OCN table.

Click the "Send" button or [Shift+ Ctrl+ F-4].

- When processing is complete the "Sent" date/time will be populated.
- The "Faxid" is also populated if delivery is FAX

LEAP (Local Exchange Automation Program) can be used to send the FOC to the CLEC. This system can be used should the LON FOC transmitting feature or fax server be inoperable. How to set up an initial account and use is explained in CDIA.

- Access Netscape by clicking on the Netscape desktop icon
- Click on Bookmarks and click on LEAP in the drop down menu
- Prepare the FOC Document in LEAP and send

If the FOC has been sent to the CLEC, and changes have been made to the service orders, such as new Circuit ID Numbers, new Service Order Number or a new Due Date, then it is the responsibility of the Service Rep to send a new FOC to the CLEC with all new information.

12.4 FOC Fax Failures

FOCs sent by LON [Order Tracking] uses a generic e-mail account to deposit fax failure notices. Enter Open Mail using the following instructions:

- Click Open mail icon
- Click Config....
- Enter User Name: LCSC FAX
- Enter Server: 90.11.244.50
- click OK
- Enter Password: LCSC1 and click Login

- Select View and hold down left mouse button moving bar down to “By Title” and select.
- Highlight (7 or 8) by holding [Ctrl] and clicking the mouse on each title
 - Select YAXQA## to get the Atlanta fax failures
 - Select YAXQB## to get the Birmingham fax failures
- Print selections, making sure all you selected prints
- Delete selections from openmail

Access [Order Tracking] LON to refax the failures.

- Select the [Order Tracking] icon on the Exceed desktop.
- Click [New Query] or [Shift F-1] with the keyboard to access the New Query screen
- Key in the LON number in the LON field
- Click [Retrieve] or [Shift F-2] to start the query
- When the LON record comes up, Select [Orders] or [Shift F-9]
- On the Orders Screen, Click [Post FOC] or [F-10]
- The FOC screen comes up
- Check the Company Code (CC) on the LON record and match it to the CLEC Default Fax Number list [Birmingham] or the fax number on the LSR in the paper file or the image in LOIS [Atlanta]

12.5 Sending a Manual FOC or Clarification on an Electronically Received LSR

Order Tracker will no longer be used to send a subsequent FOC on an electronically submitted order. Effective April 7, 2001 LEO will allow users to send subsequent FOCs when changes have been made to a SOCS service order that generates a FOC. Please refer to chapter 16.0 of the LEO users guide for further instructions.

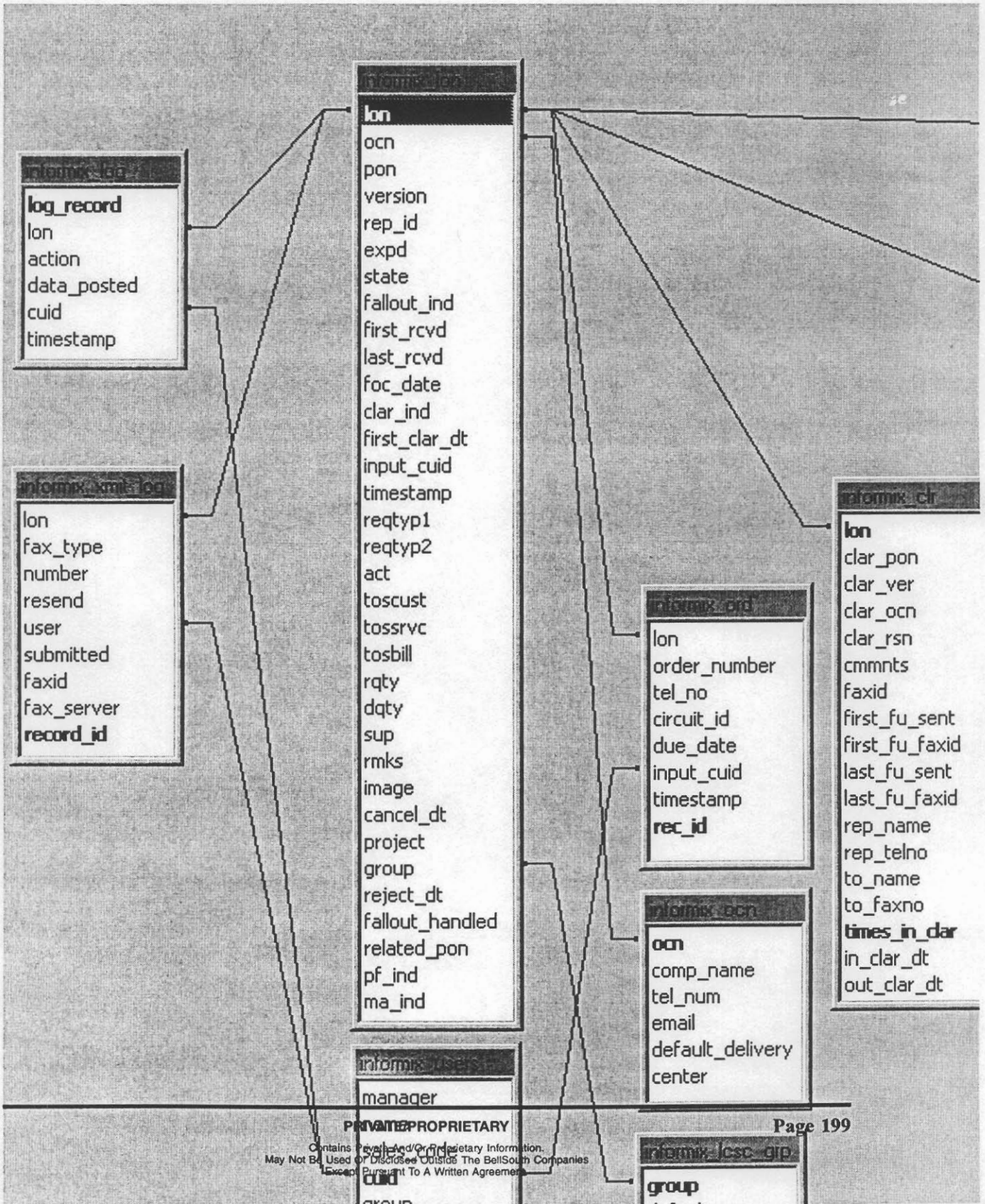

15.2 Table Relationships

The **lon** table is the “main” table in the LCSC Order Tracking System. Each Unique LSR which is manually handled should have a single entry (regardless of the version). The system assigns each unique ocn/pon with a unique serial number called the LON. Each entry in the **lon** table may correspond to from zero to many records in the **ord** table depending on the number of orders resulting from the LSR. Each entry in the **lon** table may or may not have corresponding records in the **clr** table. A **clr** table record is created when the FAX Clarification feature of the application is used to transmit each NEW request for clarification. Each entry in the **lon** table may or may not have corresponding records in the **foc** table. A **foc** table record is created when the FOC feature of the application is used to transmit a NEW FOC notice. Each entry in the **foc** table should have at least one corresponding record in the **foc_ord** table. A **foc_ord** table record is created when the FOC feature of the application is used to transmit a NEW FOC notice. Each entry in the **lon** table may or may not have an entry in the **rej** table. Whenever there is a **rej_date** populated in the **lon** table, there should be a single **rej** record with the same **lon** number. For each Reject record there should be one or more **rej_rsn** entry(ies). The **rsn_list** table gives the descriptions which correspond to the reason numbers in the **rej_rsn** table, The **lcsc_grp** table controls the available selections of the “group” list box in the Combined View LON Table section. The **users** table is maintained by the center as a cross reference of center user information. The **ocn** table is maintained by the center as a listing of customer information. **Lon** entries are not allowed for **ocns** not in this table. The application only allows transmittal of an Email FOC if there is an Email Address entered in this table for the corresponding **ocn**. The **lcsc_hol** table is a list of holidays for exclusion from duration calculations. The **tn_stop** table is a listing of telephone numbers for exclusion from being a fax destination. The **cc_stop** table is a listing of company codes to be excluded from LON input or update. The **xmit_log** contains a record for each fax submission. Fax IDs in the **xmit_log**

16. QBE (Query By Example)

16.1 Creating QBE (Query By Example) Criteria

When New Query is chosen the fields in the window (the top row of a grid form) are ready for input of limiting criteria. In any number of columns you may enter criteria and logical operators to limit the retrieval of information to just what you desire when the "Retrieve" button is clicked. No entry in a field corresponds to ANY. Therefore if no criteria are entered in any field and the "Retrieve" button is clicked then you will attempt to retrieve ALL records. Entry of a string into a field is the equivalent of saying "find the records where this field is equal to the string input." Entry to multiple fields is the same as saying "find the records where this field is this AND that field is that AND etc. Only records which meet ALL criteria will be displayed as a result. The system is CASE SENSITIVE. However, all fields will automatically UPSHIFT entries because the database is in all upper case (except the comments in the foc and clr tables). Logical operators allow further refinement of the search. A summary of logical operators is available in this application window by choosing the "QBE Help" item from the "Help" menu.
