NOTICE OF PROPOSED AGENCY ACTION
ORDER CANCELLING ALTERNATIVE LOCAL EXCHANGE
TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service
Commission that the action discussed herein is preliminary in
nature and will become final unless a person whose interests are
substantially affected files a petition for a formal proceeding,
pursuant to Rule 25-22.029, Florida Administrative Code.

BroadRiver Communication Corporation (BroadRiver
Communication), holder of Alternative Local Exchange
Telecommunications Certificate (ALEC) of Public Convenience and
Necessity No. 7430, has requested the cancellation of ALEC
Certificate No. 7430. BroadRiver Communication has complied with
the provision of Rule 25-24.820(2), Florida Administrative Code, by
providing adequate notice in writing of its request for
cancellation of its ALEC certificate and by submitting its
Regulatory Assessment Fees (RAFs) for the year 2000. Accordingly,
we find it appropriate to cancel ALEC Certificate No. 7430,
effective September 4, 2001. We are vested with jurisdiction over
this matter pursuant to Section 364.335, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for the year 2001 will be mailed to BroadRiver Communication. Neither the cancellation of its certificate nor the failure to receive a RAFs Return notice for the year 2001 shall relieve BroadRiver Communication from its obligation to pay RAFs for the year 2001.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that BroadRiver Communication Corporation's Certificate No. 7430 to provide Alternative Local Exchange Telecommunications services is hereby canceled, effective September 4, 2001. It is further


ORDERED that BroadRiver Communication Corporation shall remit Regulatory Assessment Fees for the year 2001. It is further
