

**BELLSOUTH TELECOMMUNICATIONS, INC.'S NOTICE OF  
INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Specified Confidential Classification and states:

1. In Order No. PSC-01-1973-PCO-TL ("Order"), issued October 4, 2001, the Florida Public Service Commission ("Commission") established an expedited process for reviewing the denial of a central office code request by the North American Numbering Plan Administration ("NANPA"). As part of that expedited process, the Order requires any carrier seeking the reversal of a decision by NANPA to deny a request for additional numbering resources to provide the Commission with the following information: (1) the customer's name, address, and telephone number; (2) the utilization thresholds for every switch in that particular rate center where additional numbering resources are sought; and (3) the months-to-exhaust for every switch in that particular rate center where additional numbering resources are sought. Order at 7.

2. Pursuant to the Order, BellSouth is providing the Commission with the required information regarding BellSouth's request for additional numbering resources in the Miami exchange, all as set forth in BellSouth's Petition in the above-referenced docket.

3. Because the information contains competitive business information, as well as confidential and proprietary business information, BellSouth now files this Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Commission to take possession of the documents without delay. The original of this notice has been filed with the Division of Records and Reporting, and a copy has been served on all parties of record.
