<u>ISSUE 1</u>: What are the appropriate final purchased gas adjustment true-up amounts for the period January, 2000 through December, 2000?

<u>ISSUE 5</u>: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

OPC: The factor should be effective for all meter readings on or after January 1, 2002, beginning with the first or applicable billing cycle for the period January, 2002 through December, 2002.

## Company-Specific Purchased Gas Adjustment Issues

<u>ISSUE</u>: Should voluntary funding of the Gas Research Institute (GRI) surcharge be recovered through the purchased gas adjustment true-up cost recovery clause as proposed by Peoples Gas System?

- OPC: No. Voluntary contributions should be just that. Therefore stockholders should make these "voluntary" payments rather than forced extractions from ratepayers.
