**Re: Docket No. 011321-EI - Florida Power & Light Company's Request for Confidential Classification of Material Provided Pursuant to Audit No. 01-067-4-1.**

Dear Mr. Stone:

The Commission is in receipt of Florida Power & Light Company's (FPL) request for confidential classification in connection with the Commission staff audit entitled "Allocation methodology for costs charged from FiberNet to FPL for the estimated year ended December 31, 2001 (Audit Control No. 01-067-4-1)" filed on September 27, 2001. Upon reviewing FPL's request, staff has discovered a technical deficiency in the information for which FPL has requested confidential classification.

It appears to staff that portions of the request ask for confidential classification of material which describes the allocation of general costs between FPL and its affiliate. Staff has identified WP 1 Report, pages 1-3, 5-8, and 10-11, as containing such information. In Order No. PSC-93-1062-CFO-TL, issued July 21, 1993, the Commission found that allocation factors and miscellaneous facts could not be used for any meaningful purpose and denied this type of information confidential classification.

In light of this past Commission finding, please review WP 1 Report, pages 1-3, 5-8, and 10-11, and provide additional justification as to how the release of this information will harm the utility. Please submit the additional justification supporting the confidentiality of this information within 14 days.


